Lisa has been negotiating with the Prescott Resort for the Annual Conference. The contract is nearly ready to sign, and she will send it out to the board for review. The venue will provide much of the A/V and a discount on food purchases.

#### **Review of Financials**

The insurance renewal will come due in May. The Outreach Service Award check has been sent out. Danielle has been working on getting plaques for award winners. The quote for the plaques is about \$1,200, not including shipping. Natalie reported two additional institutional members and ASU has been invoiced for \$5k to become another institutional member. We've also added a paraprofessional and five student memberships. Natalie reported on income and expenses, and we continue to operate in a deficit. Investments are still down but are recovering. Our



advisor with Charles Schwab is preparing the quarterly report with recommendations for improvements. Many of the subscriptions for the website are due in July. Danielle sent a Natalie a list of all subscriptions related to the website and recommended three to cancel. The board voted to cancel those three services, which were cancelled in March.

- The partnership around Citizen Science is now focused on the month of April, which is considered Citizen Science Month. A webinar called "Celebrating Citizen Science in Libraries" is current scheduled for April 27, 2022, to celebrate the work libraries across the country will be doing during that month.
- The Library Reopening Spreadsheet is being updated with current library operational changes due to the Omicron variant. A new version was released on Friday, April 1.

- Arizona Memory Project data migration is about halfway complete. Staff got a sneak peek and are very excited to share the new & improved site with the public later this year.

- Arizona Genealogy Day was very successful, with more than 700 registrations from all over the world.
