**Purpose:** To create bridges between FDC3 Desktop Agents (DAs), allowing apps running in differents DAs to interoperate with each other:

- Message exchanges complete in need of reviewers!

### BackPlane A Desktop Agent Bridging Implementation

#### **Description:**

- ✓ Workflows can be spanned to multiple desktop agents (DAs) on desktop.
- ✓ Workflows can be spanned across multiple machines, operated by same user.

#### **Project includes:**

- Backplane desktop service (message bus)
- .NET client code for bridging legacy .Net applications (modeled as a Desktop Agent)
- Javascript Client code (to ease implementation by Desktop Agents)


### Join the Debate

### FDC3 for the Web (<u>#896</u>)

- Significant interest in enabling FDC3 in a browser (without an extension or container)
- But...
  - FDC3 2.0 requires window.fdc3 global not provided by browsers
  - Using proprietary modules in apps achieves 'intra-op' rather than 'interop'
- Hence, work needs doing in the FDC3 Standard to achieve: secure, open, FDC3 interop on the web


