Qualification and Experience:

<u>Post No.1(cat-1)</u>: A First class Engineering Degree in Electronics and Communication / Electrical & Electronics with minimum 60% marks in aggregate from any recognized Institution/University with one year post qualification experience in the field of Testing / Maintenance of Computers / Electronics & Communication systems.

Post No.1(cat-2): A First Class BE/B.Tech in Computer Science with minimum 60% marks in aggregate from any recognized Institution/University with one year post qualification experience in the field of .Net Technologies, VB Net, MySQL, IIS, Crystal Reports, Web Technologies and Advanced Excel. Working knowledge of R/Python would be an added advantage.

Electronics with minimum 60% marks in aggregate from any recognized Institution/University with one year post qualification experience in the field of nuclear instrumentation, radiation detectors, electronics Instrumentation and Testing and troubleshooting of electronics cards/systems or any relevant experience on electronic system or radiation detectors/instruments.

<u>Post No.2</u>: A first class Diploma in Engineering with at least 60% aggregate marks from any institution recognized by the State Board of Technical Education in Electronics and Communication / Electrical & Electronics / Electrical Engg. Should have one year post
