At the SBA, she led a team of more than 3,000 employees and managed a loan guarantee portfolio of over \$100 billion. Mills is credited with turning around the Agency, streamlining loan programs, shortening turnaround times, and reducing paperwork. These efforts resulted in record-breaking years for SBA lending and investments in growth capital. In addition, Mills helped small businesses create regional economic clusters, gain access to early stage capital, hire skilled workers, boost exports, and

tap into government and commercial supply chains.

Mills earned an AB in economics from Harvard University and an MBA from Harvard Business School, where she was a Baker Scholar. She is a member of the Council on Foreign Relations and the Harvard Corporation, Harvard's principal fiduciary governing board. She is Chairman of the Advisory Committee for the Private Capital Research Institute, a non-profit organization that seeks to further the understanding of private capital and its impact through independent academic studies. Mills is a regular contributor to *Fortune* and her writing has appeared in *Harvard Business Review* and *Politico* magazine.
