Request authorization for the Final Designation of Jewish Community Housing for the Elderly III, Inc., as Redeveloper of 132 Chestnut Hill Avenue for the affordable housing project; and, to take all related actions. (Lance Campbell presented. Financing for the project is complete, drawings and design signed off, closing scheduled for June 1, groundbreaking scheduled

for mid-June and maintenance agreement worked out with Boston Fire Department who is a direct abutter. Motion to approve was accepted.)

Article 80 Development/IDP – Not Open To Public Testimony

- 18. Request authorization to issue a Certification of Approval in accordance with Article 80E, Small Project Review of the Zoning Code for the construction of 29 condominium units, including 4 IDP units, 1,045 square feet of commercial retail space and 32 parking spaces located at 212-214 Market Street; and, to take all related actions. (John Campbell presented. Community benefits include \$4,000 for the Friends of Daly Field for field and facility improvements, \$5,000 for the Boston Police Athletic League for youth soccer, \$5,000 for Faneuil Gardens Apartments for their onsite Youth Center and \$10,000 for the Oak Square Summer Camp Scholarships. Board asked if zoning relief was consistent with future plans for the neighborhood. BPDA expressed confidence that it was. Motion to approve was accepted.)
- 19. Request authorization to issue a Determination pursuant to Section 80A-6 of the Zoning Code in connection with the Notice of Project Change for 101-105 Washington Street for the construction of 70 rental units, including 9 IDP units, 70 parking spaces; to enter into an Affordable Rental Housing Agreement and Restriction; and, to take all related actions. (Lance Campbell presented. Motion to approve was accepted.)

Public Hearings – Open To Public Testimony

32. 5:30 p.m.: Request authorization to issue an Adequacy Determination approving the Boston College Institutional Master Plan Amendment for the construction of a 115,700 square foot Field House; to petition the Zoning Commission to approve the Fourth IMP Amendment;; to consider the Project a Development Impact Project; and, to take all related actions. (Gerald Autler presented. The Chairman (Timothy Burke) recused himself. Over \$1,000,000 of linkage payments to the Neighborhood Housing Trust and the Neighborhood Jobs Trust. Drainage issues were discussed. The Board asked about the urgent need for on campus housing and asked why the 550 beds that have been in the plan for the past eight years still had not been built. Boston College explained that they did two housing projects (2150 & 2000 Commonwealth Ave), three athletic projects and will do an academic project next. Undergraduate enrollment has stayed steady at 9000 since 1972. They are at 85% on campus housing. Boston College Task Force and Carpenters Union all in favor. Motion to approve was accepted.)

Administration & Finance

35. Request authorization to expend \$295,000 from the Boston College funds to four non-profit entities in Allston-Brighton; and, to enter into grant agreements. (Gerald Autler presented. The Chairman (Timothy Burke) recused himself. Out of ten applications, six were approved, two of which there are still ongoing discussions. Didn't want to hold up approval of the other four. Motion to approve was accepted.)

36. Request authorization to expend \$1,900,000 from the Harvard Allston Public Realm Flexible Fund to the Boston Parks and Recreation Department Smith Field. (**Gerald Autler presented.** Funds will be used to help finance Phase 1 of the reconstruction of Smith Field scheduled to begin later this year. Motion to approve was accepted.)
