We have much pleasure to convey that AIBPARC, Karnataka State Committee organised a massive Dharna and protest demonstration at the Freedom Park, Bengaluru, on 25<sup>th</sup> May, 2023. The venue was decorated with display of colourful posters demanding immediate resolution of the pending demands of the retirees of the industry. The full-throated slogans raised by the participants demanded immediate implementation of the Regulation no. 35 (1) by IBA/Govt. The large gathering raised their voice for 100% DA Neutralisation to pre-November, 2002 retirees, medical insurance at affordable cost, computation of special allowance for the purpose of calculation of superannuation benefits, extension of one more option to the eligible retirees, consultative status for the organisation etc. The gathering also raised the demand that all persons who joined the Banks in post April, 2010 should also be brought back under the coverage of Bank Employees Pension Regulations (1995).
