

CERTIFICATION CREDIT

The National Association of the Catechesis of the Good Shepherd offers certification for Level II after completion of Parts 1 and 2 (90 hours).

The Office of Religious Education of the Archdiocese of Kansas City in Kansas will grant 60 hours toward religious education catechist certification.

WHO MAY ENROLL IN THE CLASS?
