You requested to kindly provide the following information in reference to the clarification issued to DOPT and mentioned in DOPT U.O.no.7/7/08-CS.I (A) dt.22/12/2010 vide MOF (DOE) U O No.10/1/2009-IC dt.14/12/2009.


1. The MOF (DOE) Implementation Cell clarification vide 2(c) the item clarified that the fixation of the pay of the official promoted as Assistant/PA's between 01/01/2006 to 31/08/2008 . Kindly provide the relevant information from the Central Civil Service (Revised Pay rules 2008) is made applicable in the said clarification.
2. Applicability of the fixation option as per clarification vide 2(c) 3rd para for only Assistant/PA's and for all ministries/department where promotion take places after 01/01/2006 to 31/08/2008 . And the option of fixation from the promotion date can be opted & the fitment chart of upgraded scale will be made applicable.
3. The clarification issued by MOF(DOE) vide U.O No. 1/1/2008. IC dt.13/10/2008 & the clarification issued vide U.O no. 10/1/2009-IC dt.14/12/2009 item 2(C) . As both the order are given regarding fixation of upgraded scale & are contradictory to each other . So Kindly provide us the information that the clarification issued subsequently on dt. 14/12/2009 will be applicable to all ministries/department or it is not applicable to other ministries..
4. The clarification issued by MOF (DOE) vide U.O No. 1/1/2008. IC dt.13/10/2008 is not made applicable for the Assistant /PA's of CSS staff. The copy of reference document shall be provided on which the different fixation option has been given to Assistant/PA's.
5. The Clarification issued by the MOF Implementation cell U.O no. 10/1/2009-IC dt.14/12/2009 item 2(C) . If it is as per CSS Pay Rule 2008 then the information required for non applicability to other ministries/department
6. Whether the clarification issued in reference to option of fixation as per 2(c) is applicable for similar fixation to all upgraded scale as per gazette notification and it can be made applicable to all other ministry & department where the scale are upgraded as per recommendation of 6th PC .

The requisite fees of Rs. 10/- in the form of postal order no.92E 892937 is enclosed in favour of Ministry of Finance (Department of Expenditure) for the above information under RTI Act 2005 .


