The World Justice Project (WJP) is seeking a developer to work in tandem with the in-house design team to build a high-quality interactive web application/tool that maps availability and access to global legal needs survey data worldwide. This tool will be titled "*Atlas of Legal Needs Surveys*."

### **About the World Justice Project**

The World Justice Project (WJP) is an independent, multidisciplinary organization working to create knowledge, build awareness, and stimulate action to advance the rule of law worldwide. WJP produces original, independent research and data about the rule of law, including the *WJP Rule of Law Index*; promotes understanding and appreciation for the rule of law, its relationship to development, and effective strategies to strengthen it; and connects and builds an engaged global network of policymakers and advocates to advance the rule of law through strategic partnerships, convenings, coordinated advocacy, and support for locally led initiatives.

### **Key Users of the *Atlas of Legal Needs Surveys***

The WJP intends to promote this tool among policymakers, donors, and researchers. This interactive map will serve as the premier database of legal needs survey data these key users can use to find information that can inform programs, policies, and research on justice issues.

### **Desired Impact of the *Atlas of Legal Needs Surveys***

The WJP becomes the go-to resource for finding and accessing legal needs survey data, produced by WJP and other third-party data producers.

### **Deliverables**

The application must have the technological functionality to visualize the geographic spread of these surveys. The application will be one page and will consist of three features:

1. Interactive global map;
2. An expanding tooltip menu that displays the legal needs surveys available in each country; and
3. Within the tooltip, buttons/links that link out to the specific surveys.

The in-house design team will provide a visual mock-up and style guide to work from.

The application must provide a resizable screen map interface with fast display using software of the developer's choice. The tool must also be accessible by public users through desktop/mobile screens.

### **Selection Criteria**

Candidates will be selected on:

1. Technical expertise: previous experience in building engaging and responsive sites with a mapping application component; and
2. Collaboration: WJP will be providing the UI prototypes, you should have the ability to work closely with the team to bring these designs to life.

### **Proposal requirements**

1. Overview of your company/your consulting history;
2. Overview of how you will meet our objective;
3. Explanation of your proposed platform/CMS;
4. Recent development examples, preferably examples that include an interactive web-based global maps;
5. Pricing with optional elements line-itemed; and
6. Terms and conditions.
