

Market Outlook (Medium Term View)

The credit policy did not have any negative surprises. Players were apprehensive ahead of the RBI policy and thus lack of negatives, ie on the CRR, reportate or reverse reportuelled a rally especially in interest rate sensitive sectors. Sensex ended the day up 208 pts at 14136.

RBI policy statement hinted at a pause on interest rate rise for the moment though there could be some tightening going ahead as RBI has set inflation target at 4.5 percent for the year. Also the RBI sees the GDP growth in India at 8.5 percent despite global slowdown. Some relief was provided on housing loans less than 20 lakh.

Banking stocks did well with BSE Bank Index rising 4 percent. Bank of India, SBI, Canara Bank, Indian Bank, Oriental Bank were among the prominent gainers in the PSU banking space. Given the lack of interest rate related negatives, real estate and construction stocks too saw buying. Parshvanath, Sobha, Unitech, Ibull Realty were among the prominent gainers in the real estate space while IVRCL, HCC saw good gains among the construction pack. Even auto stocks especially the fourwheelers did see some gains.

In the metals space, Tisco continued its upward momentum moving closer to the 600 mark. Sterlite, Jindal Stainless continued to witness buying interest among other plays.

Among prominent losers was MTNL which disappointed with its quarterly performance. Rupee appreciated further thus putting some pressure on stock prices of software companies.

FIIs were net buyers to the tune of Rs 340 cr. in cash market and they bought worth Rs 287 cr. in the futures segment. DIIs were also buyers of Rs 184 cr. in the cash market.

Asian markets are trading moderately weak. However given positive fund flows, the lack of negatives on interest front the domestic market could continue its upward momentum amid some volatility. Banking, real estate and auto stocks will remain in focus from a trading perspective. Crude oil prices were marginally weak which could trigger some buying interest in oil R&M companies.

Corporate News:

Vedanta Resources, a London based non-ferrous metals company acquiried a controlling stake of 51 per cent in Sesa Goa Ltd (owned by Japan's Mitsui). Vedanta, which owns 72.3 per stake in Sterlite Industries, announced the acquisition for \$981 million (around Rs 4,070 crore), implying a price of Rs 2,036 per share.

Maruti Udyog Ltd (MUL) reported a 24.3 per cent jump in net profit for the fourth quarter ended March 31, 2007 at Rs 448.6 crore against Rs 360.9 crore in the corresponding quarter the previous fiscal on the back of increased sales from its newly introduced Zen Estilo and Swift diesel.

MTNL has posted net profit of Rs 206 crore versus Rs 224 crore in previous quarter. For year-on-year, it has reported net profit of Rs 206 crore compared to Rs 140 crore and other income of Rs 186 crore on tax writeback.

HDFC Bank has posted net profit of Rs 343.57 crore in fourth quarter versus Rs 263.21 crore in orresponding quarter of previous year. Net interest income has increased to Rs 1117.7 crore from Rs 739.4 crore and NIM improved to 4.5% versus 3.9%.

Reliance Capital has reported net profit of Rs 306 crore (Rs 3.06 billion) in fourth quarter versus Rs 303.9 crore in corresponding quarter of previous year.
