Sujana Metal Products Ltd

(Rs 148, FY08E, P/E 6.4x, BUY with Target Price of Rs 215)

Company Background -

Sujana Metal Products Ltd (SMPL) is a part of Hyderabad based Sujana group, which has varied business interests such as Steel re-rolling, Bearings, Castings, Appliances, Towers and TMT bars.

SMPL, incorporated in 2000, is the new-age company of the group and comprises four divisions: Towers manufacturing, Structural Steels, TMT Bars and International Trade. Two trend-setting products from SMPL include Galvanised Towers and TMT, which have placed this company among the leaders in South India. They have a significant presence in other markets.

The towers division manufactures transmission towers for the power and telecom infrastructure industry. The company has a good clientele which includes names like Bharti Airtel, Reliance Telecom, Global Tele Systems, Tata Tele, Power Grid Corporation, AP Transco and Deepak Cables. Considering the strong demand scenario the company has raised its tower manufacturing capacity from 28,000 tpa to 128,000 tpa in Mar 07.

The steel division produces high grade TMT bars, besides undertaking steel processing and trading activities. The company has recently commissioned a modern automated steel rolling plant to manufacture 140,000 tpa of TMT bars and structural steel. The plant commenced production from Jul 06, and has taken to total capacity of the division to 250,000 tpa. In this division too the company boasts of a good client base with companies like Larsen & Toubro, Shapoorji Paloonji & Co., IVRCL Infra, IRCON International, Tata Projects, Nagariuna Const, etc.

Business Restructuring –

With a view to have a better focus on its individual businesses the company has embarked upon a business restructuring plan for de-merging its tower division into a separate company – Sujana Towers Ltd. (STL).

SMPL has embarked upon a business restructuring plan for demerging its tower division

The Scheme of Arrangement for transferring Towers Division of SMPL to Sujana Towers Limited and Amalgamation of Sujana Steels Limited with SMPL has been approved by the Hon'ble High Court of AP on 10th April 2007 and the Scheme has come into effect from 4th May 2007.

We believe that this arrangement shall help unlock shareholder value. The current paid up equity share capital is Rs 388.3 mn of SMPL consisting of 38.83 mn equity shares of Rs 10 each which will be split equally between STL and SMPL. Simultaneously, the face value of equity shares of STL and residual SMPL will be reduced to Rs 5 paid up shares each. Each shareholder will get one share of STL and SMPL for holding one share of SMPL.

SMPL has fixed 5th June 2007 as the record date for the purpose of scheme of arrangement.

Business Outlook & Valuation -

We continue to remain positive on SMPL and expect the stock to be re-rated following the de-merger. In our assessment the tower division and the steel business should cumulatively deliver a SOTP value of Rs 215.

Recommendation -

We maintain a price target of Rs 215

At Rs 148 the SMPL stock trades at a P/E 6.4x on FY08E consolidated EPS of Rs 23. We maintain "BUY" on the stock with target price of Rs 215. We had earlier initiated the call on SMPL at Rs 109, at the current market price the stock has appreciated around 39%.


