ECONOMY

- Annual inflation, measured in the WPI, rose to 3.79 % in the week ended 5 January 2008 after remaining steady at 3.50 % in the preceding two weeks. Inflation in the fuel group shot up by 108 basis points in just one week. It went up to 3.66 % from 2.58 % in the week ended 29 December 2007.
- The Finance Ministry has cut customs duty on 539 items as part of an agreed tariff elimination package under the comprehensive economic cooperation agreement (CECA) with Singapore. The 539 items mainly comprise of manufactured goods.

BANK

• ICICI Bank posted a 35% rise in net profit for the third quarter ended December 31, 2007. Profits rose to Rs 1,230 crore as against Rs 910 crore in the corresponding period of the third quarter.

This is a positive trigger for the ICICI bank scrip.

• Vijaya Bank plans to set up branches in China, Hong Kong, Malaysia and Dubai.

TELECOM

• In a bid to boost its triple play platform, Bharti Airtel has awarded a \$150-million contract to IBM to provide IT solutions and services to support broadcasting services such as DTH and IPTV.

AUTOMOBILE

 Jamna Auto Industries will invest Rs 120 crore for setting up two greenfield manufacturing units and modernising existing facilities. The company would set up two new facilities at Jamshedpur in Jharkhand and Pantnagar in Uttaranchal to manufacture multi leaf springs and parabolic leaf springs for automobile companies in India and abroad. The new facilities, expected to be operational by end of calendar year, would take the company's overall capacity to 2.5 lakh tons from the present 1.15 lakh tons per annum. *This is a positive trigger for Jamna Auto Industries*

FINANCE

LIC Housing Finance Ltd to make preferential offer of 84 lakh shares to two institutions. The company will be making a preferential allotment of equity shares of Rs 10 each at a premium of Rs 400 per share to First Gulf Bank (50,00,000 equity shares) and LIC of India (34,00,000 equity shares). In a communication to the BSE, it said that the board of directors has called for an EGM of the members on February 14 to approve the decision

STEEL

- Steel Authority of India Ltd (SAIL) has floated a global tender seeking to appoint a consultant which is likely to finalise a detailed blueprint on the potential of the Chiria mines. The consultant is also likely to prepare a Detailed Project Report (DPR) for the SAIL's proposed capacity expansion in Jharkhand.
- An empowered group of ministers (eGoM) will consider next month whether Essar Steel's SEZ project at Hazira has violated norms, which stipulate that such zones shall be set up on vacant land, an issue that has created inter-ministerial differences.
