Man Industries (India) Ltd.

(Rs 137.5, FY09E, EPS Rs 18.4, P/E 7.5x, BUY, Target Price Rs 190)

Man Industries India Ltd (MIIL) has disclosed its plan to list its real estate arm. We spoke to the management to get an update on the same. Here are few takeaways of the same.

Planning for real estate IPO

Man industries India Ltd (MIIL) is planning to come up with an IPO of its real estate company. The real estate arm would be jointly promoted by MIIL and Man Group UK and UAE. The management has not disclosed the exact percentage holding of MIIL in the real estate arm. The new real estate company would be adopting development model rather than a leasing model. The total investment in the real estate arm is expected to be around Rs 5000 mn. It has already purchased properties in Mumbai and Indore with the total cost of around Rs 2500 mn. The company is in the process of acquiring more land. We believe that the real estate IPO would result into value unlocking for the shareholders of MIIL.

To develop SEZ and IT parks

The company as its diversification strategy had planned to develop IT park in Indore for which it has already got in principle approval which we discussed in our initiating coverage. To continue on the same strategy, the company has purchased land with the cost of around Rs 1000 mn in Indore. Besides this it has also purchased properties in Mumbai which cost around Rs 1500 mn.

Decent volume growth expected in Q3FY08

The newly commissioned HSAW mill of capacity 2 lakh tones per annum at Anjar has started commercial production and would contribute to Q3FY08 financials. The newly commissioned Anjar facility is producing pipes for executing US \$ 225 million of order from Kinder Morgan. The company has maintained its revised topline guidance for FY08 at Rs 16000 mn with the EBITDA margins of 12%.

Business Outlook & Valuation –

Financial Estimates -

Since the exact structure of the real estate arm is not clear we continue our previous financial estimates which do not include any expected contribution from the new business.

We expect 45% growth in the topline of the company in the H2FY08 over H2FY07.

Recommendation

We believe that expansion would accrue benefit to the company from the Q3FY08 onwards and expect 45% growth in the topline of the company in the H2FY08 over H2FY07. We maintain our previous estimates and expect the topline and bottomline of the company to grow at a CAGR of 40% and 53.7% respectively during FY07A-FY09E. On the basis of FY08E and FY09E fully diluted EPS of Rs 13.4 and Rs 18.9, the scrip is trading at P/E of 10.4x and 7.5x respectively and thus is at a discount to its peers. We had recommended BUY on the scrip with target price of Rs 190. We believe that the scrip is a good long term buy and maintain our recommendation and target price.

Market Commentary:

We maintain our stock specific view on the markets. Advance decline ratio was at 1.05:1 at BSE. Stocks which should be accumulated as investment ideas are Tata Motors and Orbit Co. & SRE Infra.

New Investment Idea:

Plethico Pharma Ltd.: Unlike other pharmaceutical players in the Indian market who are fighting for a pie of the available export generics opportunity, Plethico Pharma Ltd (PPL) has adopted a completely different path by focusing on high margin Herbals and Nutraceuticals in the International markets. Plethico was primarily present in semi regulated markets. We believe these to be huge untapped potential for the company. We expect PPL to report strong growth in revenues of CAGR 36% during FY07-FY09E. We expect the company to record Net profit growth of CAGR 17% during FY07-FY09E. Our FY08E EPS is of Rs 43.8. We initiate our coverage on the company with a 'BUY' at target price of Rs 569.

Market Gossip:

Mid term trading ideas are SBI target 2610, Omaxe target 540, IDFC revised 240 & Power Grid target 180. Investment idea which should be accumulated are Mercator lines, Omaxe & Ashapura Minechem. We are expecting a fed cut of 25 basis points which in turn will be positive for sectors like Auto (Maruti and M & M) & Reality (Orbit Co. and I B Real).


