S&P Nifty (5634.60 points)

(+17.05 pts)

The Nifty opened gap up but yet again failed to cross the resistance area at 5735-57454 points. Another attempt by the Bulls met with selling pressure near the trendline resistance in purple at 5723 points giving up all the 100 points gains in the end. Banking scrips showed some resilience along with Realty scrips. The Heavy weights are still in hibernation. The A/D ratio was slightly negative and the volumes were higher than the previous session.

Weekly trendline support in the Nifty is at 5535 points while resistance at 5776 points needs to be decisively crossed to push the Bears on a back foot. Unless the 5976 points is not sustained on the upsides the Bears have an upper hand. The Bulls have to quickly get above the trendline in blue at 5689 points in close.

Intraday, pivot is pegged at 5623 points and the crucial support in the Nifty is in the 5545-5555 points' area. Resistance at 5702 points should be held for further upsides while 5725 points is critical level the Bulls have to negotiate with. Caution is advocated as range may start expanding in the next couple of sessions.

Technical recommendations



The daily candlestick chart of DRL shows that it has broken above the trendline resistance in pink in close. The volumes to have supported it; also it is near the immediate support at Rs.595-599. One can buy in very small quantities at current levels as well as in declines around Rs.602-605 with a strict stop loss at Rs.594 in close for a target of Rs.632-641 in the coming 7.8 trading sessions which if sustained in close may test the Rs.652 in the short term. Avoid gap openings and trade in small quantities.
