### **S&P Nifty (2755.10 points)**

First and foremost our condolences for those who lost their dear ones in saving India's financial capital – Mumbai and kudos to all the mavericks who blew off the heinous act of crime.

Coming back, the Nifty closed in red for the 3<sup>rd</sup> consecutive month. It surged 400 points on the first two trading sessions however failed to cross the crucial resistance at 3260 points. Selling pressure was witnessed due to profit taking at higher levels; also some utilized the rise as exiting opportunity. The Bears seized this opportunity when the 3000 points got breached. Speculative selling accelerated the fall chopping off another 500 points. Later with the odds becoming even around 2500 points, short covering emerged in the last week which helped the Nifty close 253 points above the low; albeit with a loss of 130 points. Volumes were slightly lower as compared to previous month.

Among the Sectoral Indices, FMCG and Healthcare closed positive while the downswing of another 8-10% was seen in the other sectors. Realty sector was battered down another 18%. The Nifty is pecking the trendline resistance in pink, a decisive close above it will test 2856-2870 and 2915 points. For an attempt above 3K points, 2618 points should not be broken.

Once again the strength of both Bulls and Bears will be tested. Currently the trend continuous to remain down; therefore the onus is on the Bulls to fight against the mighty Bears. A breakout from the 2630-2856 range would lead to fresh move but as mentioned the Bulls hope are alive as long as 2470 points is not breached in close. The first fortnight will be crucial for the Bulls if they survive, then 2856, 2915 and 3080 are the upper levels to be watched out.

Wipro CMP: 243.30



The daily candlestick chart of Wipro shows a recovery after a decline from 290 to 208. In its pullback it has closed on the trendline resistance in pink. If it is able to sustain above 245 there is a chance of the pullback to continue to 254-263. However failing to cross it, we may see profit taking. Support in declines is pegged at 224-227; a decisive breach of it may lead to continuation of downswing testing 210. On the flip side one can expect an optimistic target of 277 in short term. Holding period is 7-8 trading sessions.
