S&P Nifty (2708.25 points)

(+14.80 pts)

In a high volatile session, the Nifty oscillated within a 100 points range. Profit taking was seen after a flat open, but soon it bounced back 100 points. Afternoon session was quite choppy and volatile. Though it made a new low it recovered almost all the losses. Realty, IT and Metal stocks were the main losers while huge swings were seen in Banking and Reliance pack stocks. The A/D ratio was marginally positive but the volumes were lower.

Yesterday, the 2754 points (38.2% retracement of the fall from 3160-2502) acted a hurdle. If it is sustained above it on volumes then crucial resistance is at 2856 points. Until this level is not sustained treat rise as pullbacks. A contra-trend rally may be on the cards, but it is too early to say as the Bulls have to prove their strength in the coming days. High risk players can follow stop near support at 2556 and 2470 points.

Intraday, pivot in the Nifty is pegged at 2672 points. As long as it holds 2625 points, the Bulls are safe; a decisive break may lead to some more unwinding. Immediate resistance is at 2745-54 points range while a sustained move above 2778 points can lead to continuation of the upswing. The Bulls have an opportunity to slacken the bear grip. With the November F&O expiry nearing markets are expected to remain swinging, trade with a stop loss.
