Market Roundup

The Sensex has opened with a positive gap of 27 points at 13,873. Gains in early trades saw the index rally to a high of 13,929. The index, however, could not hold gains, and slipped to a low of 13,790 down 139 points from the day's high. The Sensex finally settled with a loss of 59 points at 13,787.

The market breadth was positive - out of 2,699 stocks traded, 1,407 advanced, 1,217 declined and 75 were unchanged. As per the provisional figures, FIIs were net sellers in the cash market to the tune of Rs. 69.4m.

Economy Watch

India's foreign direct investment (FDI) is expected to double to \$11bn in the fiscal year ending March 2007. Foreign investment inflows stood at \$5.5bn in the previous year. There have been huge investments coming in the software industry, financial services and manufacturing. India wants to attract capital to build up manufacturing as a mass employer for its millions of rural poor. Morgan Stanley sees India's FDI rising to \$10bn, or 1% of GDP, by 2008, with the flows mostly targeting low-capital services and manufacturing for the domestic market.

Varun Shipping Company Ltd.

Varun Shipping Company has entered into a Memorandum of Agreement (MOA) for acquiring a Very Large Gas Carrier (VLGC) having a cargo carrying capacity of approximately 76,644 cbm. The move is in line to expand its asset base in the hydrocarbon sector. The Company will be the first Indian shipping Company to acquire a VLGC. VLGC is scheduled to be delivered by July 2007.
