



Dredging Corporation of India (Rs494) Results Preview - Market performer Target Price: Rs565

Dredging Corporation of India (DCI) is expected to report marginal increase of 1.17%YoY (QoQ growth of 6%) to Rs 1.39 bn.

Operating margins improve marginally by 20 bps to 27.7% on account of lower repair and maintenance and other expenditure. Operating profit is expected to increase by 1.9% YoY to Rs 388mn. The depreciation cost is expected to increase from Rs 93.5mn to Rs 128 mn on account of amortization cost of up-gradation of one dredger. The effective tax rate for the quarter is assumed at 12% of profit before tax considering tonnage tax benefits. Overall net profit is expected to decline marginally by 0.3% YoY to Rs 309.5 mn translation into EPS of Rs 11

We expect DCI to report revenue growth of 13.5% CAGR to Rs. 6,533 mn in FY08 and net profit decline of 5.7% CAGR to Rs 1,438 mn in FY08E. We have lowered the net profit estimated for FY08 due to increased fuel and lubricant cost and depreciation. At current price of Rs 494, the stock is trading at 11.3xFY07 and 9.6xFY08 earnings and EV/EBIDTA it is trading at 5.5xFY07. We are maintaining our valuation at 11x FY08 with target price of Rs 565. (Previous Rs 680).
