Derivatives Summary

- The Nifty (March) futures traded at a premium of 11.95 points as against a discount of 5.2 points seen in the previous session and the futures added around 25.35 lakh shares in the open interest.
- The total open interest in the market is very close to Rs46,400 crore and there was an addition of Rs2,304 crore in the open interest during the day.
- The Nifty stocks added 13 lakh shares in the open interest.
- J&K Bank (36%), CESC (29%), UBI (17%), UltraTech Cement (13%) & HCL Tech (12%) were the top open interest gainers in the market.
- IVRCL Infra (-14%), Bajaj Hind (-12%), Crompton Greaves (-12%) & Patni (-6%) were the top open interest losers in the market.
- The stocks with a positive bias are Sterlite and Reliance Capital.

Market View

The market opened on a positive note and hovered around its previous close in the first half of the trading session and witnessed huge volatility in the second half of the session. In the afternoon the Nifty took a hard hit and slipped deep into negative territory to touch an intra-day low of 3956. It witnessed a strong bounce back in late trades and finally settled at 3942 with marginal gains of three points for the day. The volumes in the Nifty futures continued to be on the higher side of the average volumes indicating that volatile moves are likely to continue before the budget. There was an addition of around 25.35 lakh shares in the open interest towards the long side. On the options front the implied volatility of both the calls and puts decreased significantly indicating a positive bias for the market. We have also witnessed closure of long positions in the puts (in the money puts) while the calls witnessed addition towards the writing side, indicating that buying should emerge at lower levels. The market is likely to open on a positive note probably with a positive gap and is likely to show some healthy gains. The key support level for the Nifty is 3900 and there will be resistances around 4010 and 4050.
