Derivatives Summary

- The discount in the Nifty (March) futures decreased to -8.65 points from -27.4 points and the futures shed around 19.61 lakh shares in the open interest.
- The total open interest in the market is Rs52,336 crore and there was an addition of Rs1,700 crore in the open interest during the day.
- The Nifty 50 stocks added 31,229 shares in the open interest.
- UTI Bank (23%), Patni (22%), IPCL (19%), BPCL (17%), Maruti (17%) & ITC (11%) were the top open interest gainers in the market.
- BHEL (-11%) was the top open interest loser in the market.
- SRF (99%), IFCI (90%) & Essar Oil (86%) are close to their market wide position limits.

Market View

The market opened on a positive note and remained flat for the first hour of the trading session. It witnessed strong momentum and rallied thereafter and closed the day with handsome gains of 3.72%. We witnessed significant amount of short covering as well as addition of fresh long positions towards the end of the day. The volumes in the Nifty futures were relatively lower than the volumes on the previous trading day and the futures shed around 19.61 lakh shares in the open interest on the long side. On the options front the implied volatility of both the calls and puts declined, indicating that the market may stabilise at these levels. The market is likely to open on a positive note and should face stiff selling pressure around 3800 where a significant amount of open interest is open. The key support levels for the Nifty are 3730 and 3690 and there will be a resistance around 3800.
