City Union Bank (Rs23) Underperformer - Target Price: Rs19

In Q1FY10, City Union Bank (CUB) reported marginal de-growth of 0.7% (Y/Y) in net interest income to Rs563 mn compared to our estimates of Rs604 mn; deviation from our estimates was due to higher cost of deposits. On yearly-basis, yield on advances increased by 6 bps and cost of deposits went up by 60 bps; on quarterly-basis, they dropped by 10 bps and 7 bps respectively. Decline in CASA deposit share by 161 bps (Y/Y) also caused increase in cost of deposits. Re-pricing of deposits with lag effect, lower volume growth in credits, decreased yield on advances and parking of funds in investments at lower yields collectively resulted in decrease in margin by 72 bps to 2.36%. The bank might take some 2-3 quarters to recoup drop in margin. Surprisingly, the bank reported sharp drop in CXB income; it came down by 44% (Y/Y) to Rs37 mn; total fee income grew by 3.6% (Y/Y) to Rs177 mn. Much higher growth in treasury income led to 13.5% growth in total other income to Rs259 mn. Contained operating overheads led to flat operating profit at

Rs473 mn. In Q1FY10, total provisions were lesser mainly due to write-back of investment depreciation provisions of Rs22 mn (against provisions of Rs61 mn in Q1FY09), though the bank made higher provisions for bad-debts of Rs123 mn compared to Rs75 mn in Q1FY09. In the quarterly result, the bank reported NII lesser than our expectations but operating and net profit numbers were in-line with our estimates. We maintain our **Under Performer** rating on the stock with a price target of Rs19 at 1.1x adjusted book value FY11.

Strong growth in business: The bank's total business grew by 25% (Y/Y) to Rs139 bn on the back of 22% growth in gross advances to Rs55.4 bn and 27% growth in deposits to Rs84 bn. Current, savings and term deposits reported growth of 18%, 15% and 29% respectively leading to decline in CASA share to 18.19% from 19.8% in Q1FY09 and 18.9% in Q4FY09. Credit- deposits ratio and incremental credit-deposit ratio declined sharply; C-D ratio dropped from 69% in Q1FY09 and 72% in Q4FY09 to 66% in Q1FY10. Incremental C-D ratio decreased to 56% from 66% in Q1FY09 and 62% in Q4FY09. Much increased parking of funds to investments could further lead to stagnancy in margin.



Sharp contraction in margin: In Q1FY10, the bank's NIM reduced 72 bps to 2.36% from 3.08% in Q1FY09 and 2.71% in Q4FY09 mainly due to higher expansion in cost on funds compared to yield of funds and much lesser incremental credit-deposit ratio. Yield on funds reduced by 31 bps to 9.56% and cost of funds increased by 42 bps to 7.21%.

Strong growth in treasury income pushed other income: During the quarter, the bank reported strong growth of 13.5% (Y/Y) in non-fund based income to Rs259 mn on the back of strong performance in treasury income and flat growth in total fee income.

Asset quality in control: In the quarter, the bank's gross NPA reported increase of 27% (Y/Y) to Rs1.09 bn. Net NPAs increased by 72% (Y/Y) to Rs611 mn mainly due to reckoning of floating provisions as tier II capital rather than adjusting from gross NPAs.

In the quarterly result, the bank reported NII lesser than our expectations but operating and net profit numbers were in-line with our estimates. We maintain our **Under Performer** rating on the stock with a price target of Rs19 at 1.1x adjusted book value FY11. At current price, the stock quotes at 1.33x ABV FY11.
