Market Roundup

The Sensex opened marginally higher at 13,737. The index could barely move up to touch a high of 13,749, before slipping into the negative zone. Unabated selling in the market, amid weak Asian markets triggered by Thailand central bank's decision to impose a 10% penalty on overseas investors if they take out funds within a year of investment, saw the index plunge to a low of 13,237 down 512 points. Some short covering towards the close saw the index pull backs a bit, and settles at 13,382 down 349 points.

The market breadth was fairly negative. As per the provisional figures released by NSE, FII were net sellers in the cash market to the tune of Rs.8,227.7m.

Economy Watch

Industry body, Confederation of Indian Industry (CII) has recommended a cut in excise duty from 16% to 14%. In its pre-budget memorandum, it had asked for a reduction in the excise duty on processed foods, pesticides, energy efficient triphosphor fluorescent lamps, electric fans, caprolactum and two wheelers to 8% from 16%, on all types of cars to 16% from 24%, and to Rs.350 per tonne from Rs. 400 on cement. Currently, most manufactured products attract 16% excise duty and 12.5% Value Added Tax (VAT).

Company Announcements

National Aluminium Company Ltd. Rs. 210.10 (%)

National Aluminium Company is at the final stages of discussion with the Indonesian Government to set up an overseas Aluminum plant. The plant will be set up in a joint venture partnership with the government agencies. The estimated cost of the plant is around Rs.150bn. The company would set up a smelter and captive power plant in the overseas location. The total capacity of the plant would be around 2.5 lac tonnes per annum. This project would be funded through internal accruals and debt.

Lupin Ltd.

Rs. 567.75 (-2.22%)

Lupin announced that the USFDA has granted tentative approval for the company's abbreviated new drug application (ANDA) for Trandolapril tablets, 1mg, 2mg and 4mg. The company's Trandolapril tablets will be the AR-rated generic equivalent of Abbott's Mavik tablets. Trandolapril is indicated for the treatment of hypertension. The company intends to launch the generic on final approval, which is expected upon expiry of patent protection for the brand product in June 2007.

Hero Honda Motors Ltd.

Rs. 752.80 (+0.33%)

Honda Motor has announced that the company will launch a small car in India as it goes in for a new plant to expand capacity in the country. The company aims to produce and sell more than 1.50 lac cars in India annually by the end of 2010. The estimated investment for the new plant is around is around \$ 200m for the new plant.
