



Gateway Distriparks (Rs162) BUY - Target Price: Rs234

Gateway Distriparks Ltd (GDL) through its subsidiary - Gateway Rail Freight Pvt. Ltd. has entered into an agreement with Container Corporation of India Ltd. (Concor) to set up a Joint Venture Company (JVC) to construct and operate a rail linked double-stack container terminal at Garhi Harsaru near Gurgaon in Haryana connecting NCR to the western ports. Gateway Rail and CONCOR will have shareholding in the ratio of 51:49 respectively in this JVC. This agreement replaces the existing agreement between CONCOR and Gateway Distriparks Ltd. on train operations from ICD Garhi Harsaru.

GDL has an operational rail - linked ICD at this location. The operation of this ICD will be taken over by the JVC. At present CONCOR provides rail connectivity to this ICD. The rail operations will now be done jointly by Gateway Rail and CONCOR. Gateway Rail has already placed order for two rakes, one of which is expected to be delivered within two weeks.

The terminal will provide services in handling, transshipment and storage of containers and warehousing, value-addition, distribution and containerization of cargo. It will also have a large warehousing complex for both bonded and transit cargo with separate facilities for cold storage, reefer containers and for domestic cargo. The JVC will open a new era in inter-modal logistics in NCR reign for Gateway and Concor. The joint effort will help in consolidating cargo volumes of North India for double-stack container train operation on the diesel route from NCR to JN Port, Mundra and Pipavav. It will also be developed as a hub for rail transport of cars (CBU) and two-wheelers between North India and Western, Central, Eastern and Southern Indian locations.

At a current price of Rs 162, the stock is trading at 18.3x FY07 and 12.4x FY08 earnings and EV/EBIDTA it is trading at 13.8xFY07E and 9.4x FY08E. We have revised revenue and profit estimates from Rs 3.25 bn to Rs 3.07 bn and from Rs 1.28 bn to Rs 1.19 bn for FY08 respectively. We now expect the net profit to grow at CAGR of a 26% over next three years to reach Rs 1.4 bn in FY09. We are revising our valuation from 20x to 18xFY08 with price target of Rs 234, at which stock would trade at PEG of 0.69
