Market Outlook (Medium Term View)

The domestic market managed to close up on the last day of the F&O settlement. Pharma sector for a change did well. Among the frontlines, Ranbaxy, Reliance, ONGC, Infosys clocked gains. Even the auto sector did well be it Maruti, Tata Motors. Bankex and capital good sector were the weaker sectors yesterday while sectors like pharma, auto, technology and oil and gas showed some strength. Among major losers were Ambuja, ACC, Bharti Tele, BHEL and HDFC Bank.

In the madcap segment, stocks like JP Hydro, IFCI, Nagarjuna Fertiliser, Tata Chemicals were some of the stocks which saw interest.

FIIs sold futures to the tune of over 1000 cr. while they were net buyers in the options segment. In the cash segment, FIIs were net buyers of Rs 278 cr while DIIs were net sellers of Rs 144 cr.

The NIFTY futures closed at almost 40 pts discount to cash market which clearly indicated the possibility of a weakish opening. Add to this, the international markets have lost substantial ground on the back of sharp losses in US market. Sub prime mortgage worries, concern over yen carry trade are some factors affecting international market. The domestic market has seen significant liquidity flows and thus any sharp correction in global markets will have a negative impact on the market.

Corporate News:

Bharti Airtel reported a 71.3% increase in consolidated net profit at Rs 1,424.22 crore for the first quarter ended June 30, 2007 (Q1FY08) when compared with Rs 831.39 crore in Q1FY07., the group's total income, as per Indian GAAP, for Q1FY08 surged 54% to Rs 5,873.52 crore from Rs 3,815.49 crore in Q1FY07. As per US GAAP, Bharti's consolidated net zoomed 100% to Rs 1,511.60 crore in Q1FY08 from Rs 755.09 crore in Q1FY07. Total income was up 53% at Rs 5,904.60 crore from Rs 3,856.36 crore. The company added 57 lakh customers during the quarter increasing its market share to 23.5% from 21.1% during the corresponding period last year

Patni Computer Systems posted a net income (consolidated) of Rs 134.7 crore (\$33.2 million) for the second quarter ended June 30, 2007 - an increase of 98.9% as compared to Rs 76.6 crore (\$16.7 million) for the same quarter last year. The revenue for the quarter touched Rs 662.8 crore (\$163.3 million) - a rise of 14.2% from Rs 656 crore (\$143 million) year-on- year. Sequentially (as compared to the trailing quarter), the company's net income was up 19.2% from Rs 120 crore (\$27.8 million) while its revenue grew 4.7% from Rs 672.4 crore (\$156.0 million).

However, the figure has been shored up by other income of \$7.1 million during the quarter.

For the third quarter ending September 30 2007, the company guided revenue to be in the range of \$167-168 million (around Rs 680 crore) and net income (excluding the foreign exchange gain/loss) to range between \$18.5-19 million at a constant dollar value of Re 40.8 per US dollar for the quarter. In terms of headcount, Patni will be adding close to 1,400 employees in Q3.

Maruti Udyog reported a 35.2% increase in net profit at Rs 499.60 crore for the first quarter ended June 30, 2007 when compared with Rs 369.57 crore in Q1FY07. The company's total income increased 27% to Rs 4,154.07 crore in Q1FY08 from Rs 3,268.77 crore in Q1FY07.

Tata Power Company announced a 56.09% growth in net profit to Rs 1,902.00 million for the quarter ended June 2007 from a profit of Rs 1.218.50 million for the quarter ended June 2006. Net sales rose 9.80% to Rs 15,114.80 million for the quarter ended June 2007 from Rs 13,766.10 million in the same quarter, a year ago. Total income rose 11.45% to Rs 15,799.4 million in the quarter from Rs 14,175.7 million in the year-ago quarter. The earnings per share (EPS) of the company rose 56.1% to Rs 9.60 for the quarter ended June 2007.

Lanco Infratech on a consolidated basis posted 12 times rise in net profit to Rs 512.88 million for the quarter ended June 2007 from a net profit of Rs 42.63 million for the quarter ended June 2006. Total income rose 2.37 times to Rs 6,032.79 million for the quarter ended Jun. 30, 2007 where as the same was at Rs 2.546.64 million for the year ago quarter. On a standalone basis the company posted a 7.5% decline in net profit to Rs 169.91 million for the quarter ended June 2007 where as the same was at Rs 183.78 million for the quarter ended June 2006. Total income stood at Rs 1,568.50 million for the quarter as against Rs 1,016.99 million for the quarter ended June 2006.

ABB India's net profit during the second quarter ended June 30, 2007 (Q2FY07) went up 51% to Rs 108.6 crore compared to the corresponding quarter last fiscal. The company attributed the growth to higher sales, execution of backlog orders and higher productivity. During the quarter, revenue increased 43% to Rs 1,415.6 crore. ABB India is growing at an average of 49% year-on-year for the last three years. During the first two quarters, ABB India added 1,000 personnel, including 250 engineers, to take the total headcount to 6,500. Its Bangalore R&D centre has already emerged as the largest for the ABB group in terms of people (450 engineers). New line of work such as product development in the automation and power sector has been shifted to this centre.

Apollo Tyres reported a 187% increase in net profit at Rs 46.76 crore for the first quarter ended June 30, 2007 when compared with Rs 16.26 crore in Q1FY07. The total income increased to Rs 879.92 crore from Rs 757.37 crore in Q1FY07.

Ranbaxy Laboratories reached an agreement with GlaxoSmithKline (GSK) to stipulate a dismissal of their US litigation with regard to Valtrex (Valacyclovir Hydrochloride tablets). The lawsuit in the US was related to GSK's US Patent No 4,957,924, covering Valacyclovir Hydrochloride and its use in the treatment of herpes virus infections. Ranbaxy will enter the US market in late 2009 and will enjoy a 180 days exclusivity for the drug. The company has also obtained a license to GSK's US Patent Nos. 5,879,706 and 6,107,302, listed in the Orange book for Valacyclovir. The total annual market sales of Valtrex were around \$1.3 bn In early February 2007, the Company received a final approval from the US FDA to market and manufacture Valacyclovir Hydrochloride tablets.
