Derivatives Summary

- Nifty (Jul) futures' discount increased to 15.25 from two points and added around 6.8 lakh shares in open interest.
- Total open interest in the market is 82,245 crore and around 2,054 crore was added in open interest.
- Nifty calls added 3.1 lakh shares and puts added around 18.57 lakh shares in open interest.
- CESC (43%), India Cement (20%), IOB (15%), LITL (12%) and GDL (11%) were the top interest gainers in the market.
- Corporation Bank (-15%), SCI (-13%), PFC (-12%) and JP Associate (-11%) were the top open interest losers in the market.
- Nagarjuna Fertilizers (97%), JP Hydro (94%), Essar Oil (92%) and TTML (91%) are very close to their market wide position limits.

Market View

The market continued to rally on the back of strong momentum and positive global cues. It opened with a gap of around 40 points and remained in a very narrow range of 4490-4510 thereafter. Volumes in Nifty futures were lacklustre and added around 6.8 lakh shares in open interest towards the short side. On the option front, implied volatility of options has increased by 1-2 % across the strike price with an increase in open interest, indicating buying in both call and put options. The market is likely to open on a flat to positive note and may continue to rally as long as it is trades above 4470. Key support levels for the Nifty are 4470 and 4440 while the resistance will be around 4510-4535 levels.
