Daily Market Update January 13, 2010

US markets and European markets decline

- US stocks fell, with the Standard & Poor's 500 Index retreating for the first time this year, after Alcoa Inc.'s earnings trailed estimates and China moved to cool economic growth. The Dow Jones, S&P 500 and NASDAQ slipped 0.34%, 0.94% and 1.30%, respectively. Alcoa, the first Dow Jones Industrial Average company to report fourth-quarter earnings, tumbled 11% in its biggest drop since March. Electronic Arts Inc. plummeted 7.8% after the video-game publisher reported preliminary results that fell short of analysts' estimates. Bank of America Corp. led financial shares lower after a White House official said the government will raise USD 120 bn in banking fees to recoup losses from financial bailouts.
- The benchmark FTSE 100 declined by the most this month, led by raw-material producers, after China ordered banks to put aside more deposits as reserves in an attempt to cool the economy. The FTSE 100 index fell 39.36 points, or 0.71%, at 5,498.71. Vedanta Resources Plc and Fresnillo Plc sank more than 3% as metals prices retreated in London. Royal Dutch Shell Plc slipped 1.6% as crude oil fell.

Sensex loses more than 100 points

Reacting to mixed cues from the Asian markets, the Sensex opened on a cautious note at 17,534.10 with a marginal positive gap of 7.39 points. Thereafter, the bourse traded around the previous day's close of 17,526.71 for better part of the morning session as Alcoa's disappointing earnings weighed on the Metal stocks. However, in the early afternoon session the markets extended its gains and touched the intraday high of 17,612.00 buoyed by a better-than-expected IIP number for the month of November. However, in the late afternoon session, the markets pared its gains as investors were concerned that robust industrial production data and a recent surge in inflation will provoke India's Central Bank to tighten its monetary policy. Subsequently, in the last session, the markets touched the intraday low of 17,392.55 as a result of subdued European markets and lower US index futures. The Sensex ended the session below the 17,500 mark at 17,422.51, after losing 104.20 points or 0.59%.

The Nifty ended the session below the 5,250 mark at 5,210.40, slipping 39.00 points or 0.74%.

Commodities Market

Crude oil dropped as China raised bank reserve requirements to curb a credit boom. Gold fell after as investors decided to book profits. Copper fluctuated as investor's boosted arbitrage trading to take advantage of the price gap between London and Shanghai.

IDEA Jan-10

- The trade deficit in the US widened in November, as imports climbed faster than exports, pointing to a rebound in global demand that is fueling growth. The gap expanded 9.7% to USD 36.4 bn, the highest level since January, from USD 33.2 bn in October, Commerce Department data showed. Imports increased 2.6%, reflecting a jump in oil prices, while exports rose to the highest level in a year. (Bloomberg)
- China unexpectedly raised the proportion of deposits that banks must set aside as reserves to cool the economy as a credit boom threatens to stoke inflation. Reserve requirements will increase by 50 basis points starting Jan. 18, the central bank said. The existing level for big banks is 15.5%. (Bloomberg)
- The Bank of England should stop its bond-purchase plan after completing the current GBP 200 bn tranche as the economy shifts toward a recovery, the British Chambers of Commerce said. (Bloomberg)

Corporate Announcements – India:

- Infosys Technologies has reported a 3.6% year-on-year decline in net profit to Rs. 15.82 bn for the third quarter ended December 31, 2009.
 Total income, too, saw a decline of nearly 1% to Rs. 57.41 bn. (BS)
- Punj Lloyd has bagged orders worth Rs. 9.47 bn from Ind-Barath Energy. The scope of this project includes execution of partial balance of plant, mechanical, electrical and C&I work. The project would be executed over the next 2 years. (BS)
- Bharti Airtel, has announced that it has agreed to acquire 70% stake in Bangladesh-based, Warid Telecom. Bharti plans to make USD 300 mn fresh investment in the company, thus taking the overall investment to USD 1 bn. (BS)

Economic and Political Headlines:

Industrial growth has gathered pace as factory production rose by 11.7% in November 2009, fuelled by stimulus-backed demand for manufactured goods, particularly consumer goods. Manufactured goods, which have around 80% weight in the Index of Industrial Production, which measures industrial growth, grew by 12.7% in November 2009 compared to 2.7% in the same month a year ago. Within this category, consumer durable goods production expanded by 37.3% against just 0.3% a year ago. (BS)
