

### Commentary:

### Sensex ends in green

The Sensex opened with positive gap after touching an intraday high of 15,521 during early hours of trade, but slipped 131 points from the day's high to hit a low of 15,390 due to profit booking. It again rebounded into positive zone before closing at 15,465.4 gaining 0.28%. The rise was due to buying trend in index pivotals.

The Nifty gained 4.50 points or 0.10% to close at 4,479.25.

### Market breadth remained positive

The market breadth was fairly positive on BSE with 1,744 shares that advanced as compared to 991 that declined, while 55 remained unchanged with an advance-decline ratio of 1.8:1.

## Reliance energy gained; HDFC and L&T follows suit

Reliance Energy jumped 5.98% before closing at Rs. 823.45 emerging as top gainer on Sensex.

HDFC advanced 2.96% to close at Rs 2,059.55, after the news that it would not going to cut home loan rates.

Larsen & Toubro rose 1.40% to close at Rs. 2,623.35 on report that it received two contracts worth Rs. 267 crore from IOC and Liaoning Huajin Chemical Corporation for their expansion projects.

## Tata motors declined

Tata Motors slipped 1.70% to Rs. 691 after it reported a 0.4% fall in sales in August 2007 over August 2006.

## Nikkei fell amid weak economic data

Nikkei 225 lost 104.46 points or 0.63% before closing at 16,420.5, the decline was due to reduction in capital spending in Japan which affected the sentiment. Also, investors are waiting for the release of key US economic data for August.

Hang Seng also fell on the back of heavy profit booking. It fell 18.02 points or 0.08%, to close at 23,886.07.
