#### VIEW POINT: CONSOLIDATION SEEN

The markets did pretty well for themselves Tuesday, holding up amidst a flurry of profit booking after a two-session rise of 585 points. While the trend does not change even if we fall to a 13119 levels, I would believe that as long as the Sensex closes above the 13386 mark, the earlier resistance, now a support, it is good enough for the markets.

However, the markets may want to watch, whether the Dow is able to make a new high, above the 12796 mark. With the Dow closing just below the mark at 12773, a wait may not be a bad thing to do. The environment here is likely to be helpful to the bulls as the Nikkei is doing well and markets are likely to open higher, giving over night traders a profitable exit. The Rupee seemed to have stabilized, but that will need to be watched too. The dilution in Tisco's equity going forward is slightly more than expected, which may inspire some profit booking at the counter. Largely a day of consolidation.

#### **Across the Atlantic**

U.S. stocks finished mixed on Tuesday, with the Dow Jones Industrial Average brushing with record highs, as investors welcomed upbeat economic data as well as earnings from **Coca-Cola Co**. and **Johnson**, but remained cautious about key technology earnings due after the close

At the end of trading, the **Dow** had added 52.58 points, or 0.41%, to 12,773.04, having briefly topped its best-ever finish of 12,786.64 earlier in the session. Of the 30 members of the index, 20 were higher, led by increases in J&J and Coke, both of which rose after their quarterly earnings reports

Meanwhile, the **S&P 500** rose 3.01 points, or 0.2%, to 1471.48, and the tech-heavy **Nasdaq** slipped 1.38 points, or 0.05%, at 2516.95.

For the year, the Dow has now added 2.5%, the S&P 500 has risen 3.7%, and the Nasdaq has pieced together a gain of 4.2%.

Before the opening bell, **Coke** said first-quarter earnings topped analysts' estimates by a penny on revenue that jumped 17% from last year to \$6.1 billion.

**J&J's** first-quarter earnings fell to \$2.6 billion, or 88 cents a share, from \$3.3 billion, or \$1.10 a share, a year ago. However, adjusted results topped the Thomson First Call analysts' consensus of \$1.05 a share.

Coke climbed \$1.30, or 2.6%, at \$51.57, and J&J advanced \$1.53, or 2.4%, to \$64.55.

Helping the overall mood were positive data on inflation and the housing sector.

The Labor Department's **consumer price index** for March showed no big surprises. The CPI was up 0.6%, matching expectations. The core index, which excludes food and energy prices, rose 0.1%, slightly below estimates.

**Core inflation**, a closely monitored figure, is now up 2.5% over the past 12 months, down 0.2 percentage points from February's level. The data follow the recent producer price index, which rose a greater-than-expected 1% last month. The core PPI was unchanged

Elsewhere on the economic docket, the government said **U.S. housing starts** jumped 0.8% in March to 1.518 million annualized units. **Building permits** also rose 0.8%, to 1.544 million, last month. On average, economists expected March starts to total 1.50 million, and for permits to dip to a 1.51 million annual pace

In other economic news, the Fed said industrial production fell 0.2% in March, compared with estimates of a 0.1% rise. Capacity utilization declined to 81.4% from a revised 81.6%, also below expectations

Away from stocks, commodities lost momentum and finished lower on the day. **Crude oil** futures fell 51 cents at **\$63.10** a barrel, and **gold** gave back \$1 to **\$693.50** an ounce.

#### After Hours: Mixed bag

**Intel** Corp shares rose in late trading Tuesday after the world's largest chipmaker posted quarterly results that came in ahead of Wall Street's view, but an earnings shortfall at **Yahoo** pulled the Internet search provider's shares down by 8%.

The **Nasdaq-100 After Hours Indicator**, which tracks evening trading of the index's leading technology stocks, shed 0.69 points to end at 1,834.22.



#### THE INDICATOR

**Intel** was up 2.1% at \$21.42 after the company posted a 19% increase in first-quarter net income. Its profit was helped by a one-time tax benefit which boosted earnings by 5 cents a share. Net earnings for the period rose to \$1.61 billion, or 27 cents a share on a 1% decline in sales to \$8.85 billion. Wall Street was looking for earnings of 22 cents a share on sales of \$8.9 billion. Intel's gross margin was 50.1%, down from 55.1% a year ago

**Yahoo** shares fell \$2.58 each to finish at \$29.51. The company reported an 11% fall in first-quarter profit as operating expenses rose. Earnings came in at \$142 million, or 10 cents a share, compared with \$159.9 million, or 11 cents a share, a year ago. Analysts surveyed by Thomson Financial expected a profit of 11 cents a share. Sales rose 7% to \$1.67 billion. Revenue excluding the fees that Yahoo pays affiliates was \$1.18 billion, a 9% increase from the \$1 billion a year ago.

Shares of **International Business Machines** lost their earlier advances to close down 0.6% at \$96.50. IBM posted an 8% increase in quarterly profit to \$1.84 billion, or \$1.21 a share, from a year ago. Revenue increased 6.6% to \$22 billion. The results were in line with the consensus estimates for earnings of \$1.21 a share on sales of \$21.9 billion. Big Blue also said it expects its full-year earnings per share to grow about 11% from 2006, the midpoint between its previous forecast for growth of 10% and 12%.
