

3QFY2007 Results Review

City Union Bank (Rs173)

Market performer **Target Price: Rs185**

In 3 Q FY07, City Union Bank recorded 12% growth in bottomline to Rs139mn due to moderate growth of 13% in NII (net interest income) and sharp increase of 24% in overheads. The reported net profit of Rs139mn was lower than our expectations (Rs152mn). Lower bottomline was also due to one-off extraordinary item of Rs40mn towards provisioning for gratuity.

Robust growth in business: The bank's total business grew by 22% to Rs69.5bn on the back of 20% growth in advances to Rs28.7bn and 23% growth to deposits to Rs40.7bn.

Moderate growth in core operation: In 3QFY07, both total interest income and NII grew by 13% mainly due to 20% volume growth in advances and increase in yield on advances (YoA) to 11.23% from 10.7% a year back.

Improvement in asset quality: The bank reported improvement in non-performing asset; GNPA and NNPA declined in both absolute and percentage terms. On absolute basis, GNPA and NNPA declined by 14% and 34% respectively. In percentage GNPA declined to 4.0% in 3QFY07 from 5.5% 3QFY06 and NNPA improved to 1.46% in 3QFY07 from 2.69% in 3QFY06.

Margin and return ratios under pressure: In 3QFY07, due to decline in yield on investment and reduction in CASA ratio net interest margin (NIM) and return ratios are under marginal pressure. Yield on investments has come down by 40 basis point to 7.12% and CASA ratio has dipped by 3 bps during the quarter.

Higher growth in core operation, improvement in asset quality and rapid branch expansion in new domains would augur well for the bank. We maintain our Market Performer rating on the stock with a price target of Rs185.

EBIDTA margins remain flat around 15.1% against expectations of 17.7% on YoY basis due to higher raw material cost. Raw material cost as a percentage of sales increased from 65.2% in Q3FY06 to 67% in Q3FY07. The operating profit increased by 22.3% to Rs 718 mn. The other income increased by 31% to Rs 259 mn due to surplus cash of around Rs 2 bn. Overall, the net profit increased by 30% YoY to Rs 629 mn translating in to EPS of Rs 3.18 as against expectation of Rs 3.4 during the quarter. The Company has declared an interim dividend of 100% i.e. Rs 2/ - per equity share.

For FY07 on consolidated basis, we expect the revenue growth of 23.2% to Rs 21.87 bn and adjusted profit increase of 38.5% to Rs 2.5 bn. At a current price of Rs281, the stock is trading at 21.8x FY07 and 16.8x FY08 earnings and EV/EBIDTA it is trading at 16.6xFY07E and 12.2x FY08E. The valuation looks attractive given the leadership position in engines and gensets with significant growth opportunities for the company. We maintain our valuation at 20xFY08 earnings and target price of Rs335 at which it would trade at EV/EBIDTA of 15xFY08 and PEG of 0.68.
