


# **Wireless Monthly Update**

- Strong monthly net additions continue: Subscriber addition for the month of July'08 was at 9.18m, a m-o-m growth of 3%. Andhra Pradesh & Maharashtra (9.4% & 8% respectively of the total net additions) showed strong net additions.
- Bharti Airtel leads the race with net additions of 2.7m: Bharti continued to impress with its net additions of ~2.7m for the month, implying a market share of 30% of net additions. This run-rate is expected to be sustained for the next 3-6 months before new entrant's steps in and further intensify competition.
- Vodafone continued to report healthy net additions: Vodafone maintained its healthy runrate and added 1.75m subscribers. UP East & Rajasthan showed good additions & contributed 25% of the net additions.
- Tata Tele and Idea Cellular touch ~1m net adds: Tata Tele has reached the ~1m subscriber net additions, implying a 17% growth in net additions m-o-m. Idea Cellular too maintained its runrate of net additions. We expect Idea cellular to report higher net additions for the subsequent months following their Mumbai launch. Bihar circle is expected to be launched in September'08.
- Rcom subscribers net additions starting to inch higher: RCom added ~1.75m subscribers (CDMA net adds-1.38m, GSM net adds-0.37m) for the month. GSM net additions are starting to grow with increase in their coverage of 8 existing GSM circles.
- Spice Telecom cleaned up 0.35m subscribers for the month: Spice has reported a de-growth in subscriber net additions in the month. This is on expected lines with Idea Cellular taking on management control in the next 3-6 months.








## Subscriber distribution by Geography


## Subscriber distribution of net additions by Geography
