VIEW POINT: WEAKNESS PERSISTS

As expected the Sensex produced a 200-point rally in the morning on the back of international cues but at the end of the day, all but 20 points gains were frittered away amidst a late afternoon bear hammering. The propensity of the markets to develop weak knees after a good open suggests that strength of the bulls has reduced considerably on the street. On the street, the feeling is that till the DLF issue does not get over, we will continue to see these late hammerings.

The only redeeming feature of Monday's late slide is that it came on low volumes. Volumes in the F&O segment were 29% lower as compared to Friday. Though the discount in the Nifty Futures decreased to 19 points from 23, it is still substantial. FIIs covered some of their shorts and were seen as marginal buyers in the cash segment also. The Sensex has a support at 14010 and the Nifty at 4126. These supports will need to hold. Any close below these will trigger more short sales, though intraday excursions beyond these levels can turn out to be reversal points.

Across the Atlantic

U.S. stocks finished mixed and little changed after a volatile session Monday, as investors continued to monitor rising global interest rates amid more signs of global growth and hawkish talk from a Fed official.

The **Dow Jones Industrial Average** edged up 0.57 point to 13,424.96, and the **S&P 500** gained 1.45 points at 1509.12. The **Nasdag** slipped 1.39 points to 2572.15.

Considering the action of the past few days, traders were keeping a close eye on the movement of the fixed-income market. Lately, the **10-year Treasury** was down 10/32 in price, yielding **5.15**%, and the **30-year bond** was dropping 21/32, yielding **5.26%.** Prices and yields move in opposite directions.

Pimco bond expert Bill Gross, who last week said the yield on the 10-year could reach 6.5% in the next five years, was out with new comments, saying this time that it might take six months or more before the **Federal Reserve** moves to cut rates.

The fed funds target has been 5.25% since last June, and coming into this year many traders were looking for at least one reduction. However, those hopes have taken repeated blows in recent months as signs of economic strength and the potential for inflation have persisted.

Meanwhile, among stocks, a handful of small deals were making news on the merger front, but the day was absent any of the giant private-equity takeouts that have become almost commonplace.

IBM said it will acquire Sweden's Telelogic in a transaction worth about \$745 million, and **Back Yard Burgers** agreed to be taken private in an arrangement worth around \$38 million.

Meanwhile, another bidder for **Dow Jones** could eventually be a possibility after all, according to a published report. *The Wall Street Journal* said **General Electric** and **Microsoft** discussed a way to combine some parts of the publishing company with NBC/Universal by countering **News Corp.'s** \$5 billion offer, but they couldn't reach a pact.

Elsewhere, Friedman Billings upgraded **Wachovia**, and HSBC lifted its view on **Nike**. Also, UBS upgraded **H&R Block**.

As for commodities, crude oil climbed \$1.21 to \$65.97 a barrel, and gold increased \$8.70 to \$659 an ounce.
