# VIEW POINT: STILL SLUGGISH

The markets closed in near neutral territory Thursday, managing to overcome afternoon losses. The Sensex remained above its Wednesday's low is some solace to the markets, which still remain indecisive. There are no clear clues from the global markets.

The open interest (OI) has reached Rs 61315 cr, still short of all time high OI seen on January 24 at Rs 63586 Cr. The discount has increased by three points 8 in the Nifty Futures, where the OI increased by 1.6%. So far things are pretty acceptable in the derivative arena. A lot depends on ONGC, which has bagged 24 oil fields in NELP VI. Support exists for the Nifty in the 4170-4188 region.

#### Cabinet approves diluting stake in PSUs

Cabinet Committee on Economic Affairs (CCEA) has given approval for allowing **BEML** to raise funds for its modernisation and expansion programme through public issue of 49 lakh shares of Rs 10 each. After the public issue, the government equity would come down to 54 % From 61.2% with the balance 46 % being with institutions and the public

BEML is to come out with a book-building issue targeting a mop up of around Rs 600 crore.

In addition to this, the government also approved IPOs of REC, Power Grid Corp and NHPC. Post-issue, the government holding in REC will come down to 81.32% while it will be reduced to 86.3% in case of Power Grid and NHPC.

Cabinet also approved the rehabilitation package for HOCL as well as the part land sale of HOCL. The government is to mop up Rs 420 cr via REC IPO and Rs 970 cr via Power Grid. It will raise Rs 1090 crore via NHPC IPO.

#### **Govt announces NELP VI allotments**

The government has announced the NELP VI allotments. **ONGC** has won 25 oil & gas exploration blocks, including 12 deep-water blocks, under the sixth round of New Exploration and Licensing Policy (NELP VI). **Reliance Industries** has been awarded seven deep-sea blocks. **Reliance Natural Resources Ltd.** (RNRL) has bagged just one block while **Essar Group**, **Adani Group** and **Gujarat State Petroleum Corp**. (GSPC) have won two blocks each.

The Government approved the award of 52 oil and gas exploration blocks. India had offered 55 blocks in its latest licensing round. The Government had received 165 bids from domestic and overseas players for 52 blocks. There were no bids for three blocks.

#### **Across the Atlantic**

U.S. stocks closed lower on Thursday, even as late gains in technology and energy contained losses for the broad market, after HSBC Holdings, the world's third largest bank, warned that bad debts were on the rise in the U.S

The **Dow Jones Industrial Average** lost 29.24 points, or 0.23%, to 12,637.63, and the **S&P 500** was off 1.71 points, or 0.12%, at 1448.31. The **Nasdaq Composite** was down 1.83 points, or 0.07%, to 2488.67.

Homebuilders were the worst performers of the session following a weak revenue forecast from **Toll Brothers** . The Philadelphia Housing Sector index fell 2.1%.

Meanwhile, publicly traded lenders dropped. **HSBC** said it would have to spend 20% more than originally thought this quarter to cover loans that went bad, sending its shares lower by 2.7% to close at \$89.78.

Financing concerns Countrywide Financial and Novastar also finished with losses.

Before the market opened, investors started sifting through the barrage of monthly retail reports, most of which beat expectations. **Wal-Mart** confirmed this weekend's announcement about its January sales, saying comparable-store revenue climbed 2.2% last month.

Generally speaking, stocks haven't moved a great deal this week, but tech shares finally caught a bid Wednesday thanks to gains in networking leader **Cisco**. The Nasdaq rose 19.01 points, or 0.77%, to 2490.50.

As for the Dow, it hit an intraday record high of 12,700.28 but pulled back to finish up just 0.56 point at 12,666.87. The S&P 500 added 2.02 points, or 0.14%, to 1450.02.

Following the previous close, Dow component **Disney** posted strong earnings, buoyed by asset sales and a solid performance by its film studios. Excluding items, Disney earned 50 cents a share, topping estimates by 11 cents. Revenue rose to \$9.73 billion for the first quarter, up from the prior year's \$8.85 billion. Disney slid by 19 cents, or 0.5%, to \$35.29

Commodities finished a choppy session with gains. **Oil** was higher by \$2 to close at **\$59.71** a barrel, its highest level of the year. **Gold** ended with a gain of \$5.50 to **\$662.80** an ounce, and **Silver** added 11 cents to \$13.82 an ounce
