## Resistance at 4033

The Nifty traded firm above the 4000 level and touched an all-time high around 4033 during the day. The index ended the trading session near its short-term target of 4020. Intra-day the Nifty is likely to witness huge volatility and it faces resistances at its short-term target of 4020 and at its all-time high at 4033. Profit taking should be expected around 4020 and 4033. Intra-day profit booking is expected on every rise as the market is in uncharted bull territory and one should be cautious at higher levels. On the downside there is a support at 3985 and on a break below 3985 the next support is at the 10-DMA at 3964. As long as the Nifty closes above the 10-DMA, the bias is up.

Sterlite should test Rs590 and it has a support at Rs570. Reliance Capital appears strong and on the upside it could target Rs630. The stock faces a resistance at Rs610. Century Textile could test Rs680 and it has a support at Rs660.
