- Tata Group Chairman Ratan Tata threatened to pull out of Singur saying that it was not possible to work in an atmosphere of tension and distrust. BS

Sunil Hitech Engineers Ltd.

(CMP Rs 178, FY09E EPS Rs 17.2, FY09E PE 10.3x, BUY Target Price Rs 280)

We attended the conference call of Sunil Hitech Enegineers Ltd (SHEL). Key highlights of the same are as follows.

- SHEL intends to grow at 100% in FY09 and target to achieve Rs 6000 mn of revenue. The growth will be fuelled by execution of strong order backlog of Rs 13746.5 mn.
- SHEL has a strong order book position of Rs 13746.5 mn which is 4.5x its FY08 net sales. Out of Rs 1374.6 mn of order book, Rs 700 mn of job is fixed price and rest carries price variation clause upto 15%. 97% of the contracts are from power projects and 3% from steel sector. Orders are to be executed in the next 24-30 months. The breakup of power sector order (97% of total) includes 7.8% from T&D, 62% from generation, 24% from EPC and 3.2% from Hydro power.
- The company is currently L1 in Rs 1500 mn of order which is to be added in the current quarter.
- SHEL recently bagged Rs 3290 mn of EPC contact from Gangakhed Sugar and Energy Pvt Ltd which involves Rs1450 mn for 30 MW cogen power plant, Rs 1400 mn for Sugar plant and Rs 500 mn for Ethanol plant. The project is expected to be completed in the next 18 months.
- Post completion of this order, SHEL would be eligible for power EPC project upto 120 MW.
- SHEL is targeting 14% of EBITDA in the EPC contract also.
- SHEL will be moving up in the value chain after completing the EPC contract. In 1 MW power plant costing Rs 50 mn, SHEL currently has opportunity to do 7.5 mn to Rs 10 mn of contracts. This will further grow to Rs 20 mn once it completes the EPC contract of 30MW.
- SHEL will be doing Rs 250-300 mn per annum of capex in the next two years. In Q1FY09 it added Rs 150 mn of gross block.
- The current debt on its balance sheet is at Rs 1280 mn with 12.25% as average cost of debt. The debt equity ratio is at a comfortable level of 0.5x.
- Working capital management has witnessed substantial improvement. Debtor days in Q1FY09 decreased to 80 days from 105.7 days in FY08.

We have maintained our financial estimates. We expect the topline and bottomline of the company to grow at a CAGR of 49.6% and 32.8% respectively during FY08A-FY10E. On the basis of FY09E and FY10E diluted EPS of Rs 17.2 and Rs 23.9, the scrip is currently available at 10.3x and 7.4x respectively and looks attractive for long term investment. We maintain BUY and target price of Rs 280. At our target price, the scrip discounts FY09E and FY10E EPS by 16.3 and 11.7x respectively.

Market Gossip*:

View remains stock specific from current levels. Crude currently trades at 114.50 \$/ barrel. FII's were sellers in Friday's trading session, they were net seller of Rs 833 Cr (Cash + Futures). The domestic institutions were net buyers of Rs 450 Cr. We had witnessed good amount buying in sectors like Metals (up by 1.62%), Banking (up by 1.18%) and FMCG (up by 1.10%). Stocks like BOI, BRFL, Cairn and Titan can do well in short term (day or two) as the under current in these shares are quite positive. Mid term trading ideas which we continue to like from current levels are Bombay Dyeing (Target Rs 603), SAIL (Target 162) & RPL (Target Rs 171). Traders are advised to maintain strict stop loss of 5-7% on all trading calls.


