The Bulls concluded the October series on a high note with 11% gains. Huge swings and high volatility tested the nerves of market players. Reliance pack was the leader while Banking, Power and Metals supported from time to time. IT and FMCG sectors continue to under perform. Contribution from 2nd run and Midcap scrips is worth noting. The A/D ratio was marginally positive while volumes were marginally lower than previous session.

Yesterday the markets opened flat and steadily moved up to touch 5600 points (weekly R2). The Nifty completed the 78.6% retracement of the fall from 5736.80 to 5000.95 points. At the end of day and of the October series some profit taking was witnessed. As long as the support at 5328 points is not broken decisively the rally is intact. Some supply is expected in the region of 5626-5655 points which if absorbed can test the all time high.


Intraday, pivot in the Nifty is pegged at 5548-5562 points. Resistance in rallies is at 5626 points and at 5684 points in an optimistic scenario. Support is pegged at 5490 points which should be decisively breached for the Bulls to command the intraday proceedings. Volatility contracted for the past couple of sessions which is a good sign for the small traders.
