Bhagyanagar India (CMP Rs 40) BUY - Target Price: Rs63

Bhagyanagar India recently formed a joint venture company named 'Surana Ventures' for setting up of solar photo voltaic cell and module project in partnership with its promoters and a group company named Surana Telecom. The JV plans to manufacture and sell the equipment required for generating solar energy. It will be an 80% export-oriented unit with substantial tax-benefits. Bhagyanagar India and Surana Telecom will hold 40% each in the Rs 3 bn project with the remaining 20% being held by the core promoters of the company.

The project is planned at the FAB city SEZ, near to the new Shamshabad airport at Hyderabad. The company plans to reserve 25 acres for the project and has already taken possession of 10 acres at a comparatively cheaper rate of Rs 2 mn / acre. The company will acquire the rest 15 acres of land after the completion of the project (for further expansion) and is shortly going to reserve the same with a bank guarantee of Rs 30 mn. The project is likely to be commissioned and commence operations by July 2009.

According to the planned capital structure of the JV, it will have a debt to equity ratio of 1:1, with Rs 1.5 bn by way of term loan and rest through equity. The company is planning to go for an ECB (external commercial borrowing) issue and raise fund at a rate of 6-7% on the basis of premium to present LIBOR. Further, the promoter and group companies plan to contribute Rs 500 mn by way of equity and bring in a private equity / strategic investor (at a premium), who will contribute Rs 1bn. In such a case the shareholding of Bhagyanagar India will stand at 25% of the post-diluted equity.

We believe that the project will be value accretive for Bhagyanagar India but only on a long term basis as it will be essential to see whether the company can go as per its fund raising plans given the globally weak market conditions. Hence, we have not incorporated any benefit to Bhagyanagar India in terms of our financial projections. At current levels, the stock quotes at 5.8x FY08E and 5x FY09E fully diluted earnings. We rate the stock as a BUY, maintaining our price target of Rs 63, valuing its real estate business at 90% of the value of its current undeveloped land bank and other businesses of copper and telecom cables at 3x EBIDTA.
