Derivatives Summary

- Nifty (September) future premium has increased from 12.85 points to 16.45 points and around 16.40 lakh shares were added in open interest.
- Total open interest in the market was Rs85,445 crore and Rs778 crore were reduced in open interest.
- Nifty call option added 14.43 lakh shares in open interest, whereas put option shed 8.57 lakh shares in open interest.
- Great Offshore (116%), NIIT (43%), Akruti City (41%), Rolta India (30%) and Satyam Computer Services (16%) were the top open interest gainers in the market.
- Vijaya Bank (-12%), Sesa Goa (-11%), Ranbaxy Laboratories (-11%) and Essar Oil (-9%) were the top open interest losers in the market.

Market View

The market opened on a pessimistic note and Nifty started the day around 50 points lower on account of negative cues from global markets. However, some buying was seen in the initial trades, which pushed Nifty into the positive territory, but the index was unable to hold the momentum and witnessed aggressive selling pressure along with very high volatility. Nifty finally closed the session losing 96 points at 4,127. Volumes in Nifty futures were significantly higher as compared to the average trading volumes. Around 16.40 lakh shares were added in open interest with an increase in the cost of carry, indicating long accumulation. On the option front, implied volatility has increased marginally, indicating that the volatility will remain high in the market.
