

Market Roundup

The Sensex has opened with a positive gap of 33 points at 14,124, and dropped to a low of 14,110 in morning deals. However, selective buying in State Bank saw the index up in noon deals. After hitting a high of 14,278 towards the closing, the Sensex finally closed with a gain of 176 points at 14,267. The market breadth was neutral - out of 2,692 scrips traded, 1,336 advanced and 1,313 declined. As per the provisional figures released by NSE FII were net sellers in the cash market to the tune of Rs.2,417.6 m.

Economy Watch

The West Bengal government has earmarked Rs. 200bn for the power sector during the 11th plan. This would lead to a capacity addition of 3,550MW. Besides, it is spending Rs.80bn in three ongoing projects that would lead to an additional capacity of 1,500MW. The installed capacity under WBSEB, West Bengal Power Development Corporation (WBPDCL) and Durgapur Projects (DPL) is currently 7,616MW. The first phase of the 900MW Purulia pump storage project would be commissioned in March. The next three stages would be completed by December 2007.

Dabur Pharma, India's leading oncology player has announced the sale of its domestic non-oncology formulations business to Alembic. The move is in line with its strategy to focus on its core oncology business and exit other non-core businesses. The company would increasingly focus on its competencies in oncology and on expanding the research and generics portfolio in this area. Dabur Pharma, India's largest player in the oncology segment with a current market capitalization of over USD 290m, develops, manufactures and markets a wide range oncologicals.

Orchid Chemicals & Pharmaceuticals Ltd.

Orchid Chemicals & Pharmaceuticals has entered into a licensing and distribution agreement with the international generic pharmaceuticals company. Actavis for marketing 9 of the company's cephalosporin generic formulations in Europe. The products, including both sterile and oral products, would be manufactured at the company's state-of-the-art sterile and oral API and dosage form facilities, approved by USFDA and UK MHRA. Actavis would pay certain dossier license fees to the company.

BHEL Ltd.

Rs. 2,497.40 (-0.79%)

Bharat Heavy Electricals has outbid Chinese power equipment major, Harbin Power Engineering, to secure its second turnkey power project worth Rs.5,050m in Bangladesh. The order would be funded by Asian Development Bank, and would involve two 100-120MW gas turbine power plants at Sidhirganj.
