

UPDATE: SESA GOA OPEN OFFER BY VEDANTA

Vedanta Resources has made an announcement to buy the 51% stake of Mitsui & Co in Sesa Goa for a price of INR 2,036 per share. Post the acquisition, Vedanta will make an open offer for additional 20% stake in the company at a price equal to or higher than the INR 2,036 per share paid to Mitsui & Co. The offer price is at 17% premium to the current prevailing market price of INR 1,742. The chart below shows the shareholding pattern in Sesa Goa. Under the assumption that all holdings are eligible to be tendered in the open offer, *the minimum acceptance ratio works out to be 40%.*



The timelines on the offer has not been announced but the probability of the offer going onto the July expiry is quite high. Hence we will not be able to set a perfect hedge at this point of time. Buying Cash and hedging 60% of the position through June futures may involve the risk of short rolls of futures positions to July month. We will keep you updated on any further developments.
