- Very high volume on before market crash.


Short term rally on its way!

- Oscillators are entering oversold territory on the weekly charts.
- The long term support line is still intact.

Sensex has immediate resistance around 12800 levels (.618% of 5^{th} wave from 13145 to 12316) and if broken expect the "B" wave to target 13300-13600 range.
