Punter's Call


Stuck in a trading range

The Nifty traded in negative territory for a major portion of the day and took support around 3110 and bounced back to close in positive territory. For the last four trading sessions the index is stuck in the 3110-3170 range. In the near term on a break above 3170 the Nifty could test its recent high around 3200. On the downside there are supports at the 20-DMA at 3090 and at the 10-DMA at 3060. As long as the Nifty is above 3060 on a closing basis, the bias remains positive.

VSNL could test Rs380 and it has a support at Rs345. Tata Motors took support around Rs715 and on the upside it could test Rs765. Infosys has a support at Rs1,610 and it faces a resistance around Rs1,690.
