Punter's Call

One-way movement

The last 15 days were brutal for guar seed, which saw a non-stop movement in one direction, ie south. From the high of Rs2,085 guar seed came down to the recent low of Rs1,788. Technically, the commodity is highly over-sold and all oscillators reflect the same thing. Guar seed is currently trading outside the bollinger band which suggests that in

the short term a smart bounce-back is possible. The commodity's previous low was at Rs1,775 which can act as a good support. If this support holds then a bounce-back of Rs50-60 would be on the cards. On the break of Rs1,775 one can witness further weakness in the commodity.
