Sharekhan top picks

The market, extending its losses of the previous month, continued to slide in February 2009 on account of unsettling global news flow and sagging domestic sentiments due to higher than expected deterioration in the government's fiscal health. During the month, Sensex and Nifty declined by around 10.5% and 7.8% respectively and our portfolio of top picks recorded a negative return of 3.5%.

During the month, we removed Bank of Baroda (BoB) from our basket of Top Picks due to increased risk to the banking and finance industry following the persistent troubles in the global financial markets. Further, we also released a cautionary note on Hindustan Unilever Ltd (HUL), highlighting its increased premium against the Sensex and the risk of slowing volumes, which could force the stock to underperform going forward. Consequently, BoB and HUL are no more part of the Top Picks' basket. As of now, we are not replacing these two stocks on account of uncertain market conditions. However, in due course, we may add new stocks to the Top Picks' basket on the basis of our assessment and future developments.

- Remarks: With the start of crude oil production on September 17, 2008 and the commercial gas production from the KG basin expected to commence by April 2009, Reliance Industries Ltd (RIL) holds a great promise in the E&P business. The E&P business is expected to add significantly to the company's earnings and cash flow from FY2010 onwards with majority of the earnings coming from the less volatile natural gas business. The gas production will begin in small tranches initially and is expected to reach 40 million standard cubic metres per day (mmscmd) in a few months and to 80mmscmd by the end of 2009. At present, the company's reserves are estimated at 9 billion barrels of oil equivalents.
 - We expect the gross refining margin of RIL to contract in the near to medium term, as new refineries with total capacity of 1.5-2.0 million barrel per day (including Reliance Petroleum Ltd [RPL]) are expected to come on-stream in 2009 in the environment of weak demand. However, we expect RIL to fetch a premium over Singapore Complex' GRM due to its superior refinery complexity. The refining volumes would also double as RPL's refinery has become operational on December 25, 2008.
 - We believe that the margin and the plant operating rates would remain low in the petrochemical business, as the prices of petrochemical products are likely to be remain low on the back of a weak demand outlook.
 - Delay in KG D-6 gas production and adverse outcome of the court case with RPL and NTPC are the key risks to our estimates. Furthermore, the ambiguity related to likely change in the section 80IB could take away the benefit of the seven-year tax holiday from the gas production. Any further fall in the refining and petrochemical margins could result in deviation from our estimates.
 - At the current market price, the stock is trading at 12.1x FY2009E and 9.2x FY2010E consolidated earnings. We maintain Buy recommendation on the stock.

- **Remarks:** UltraTech Cement (UltraTech) is among the leading cement companies in India and is likely to benefit due to its multi-region operation. The present installed capacity of the company is 19.5 million tonne, which is 9.5% of the total domestic market.
 - UltraTech is likely to benefit from the capacity expansion and the investment in captive power plants. A 4.9million-tonne capacity expansion in Andhra Pradesh and the savings accruing on account of new captive power plants will improve the cost efficiencies.
 - Despite our expectation of subdued cement prices going forward, UltraTech's top line will grow at a CAGR of 11.7% over FY2008 to FY2010E.
 - The demand of cement is lacklustre especially in the western region and the company has 56.4% of its total capacity in the region. So if the demand fails to pick up it may lead to adverse impact on the earnings of the company.
 - Our estimates for FY2010 are based on softened coal prices, so any hike in coal prices will impact the profitability of the company (as the company imports 60% of its coal requirement).
 - At the current market price, the stock trades at a price/earning of 6.6x its FY2009 estimates an enterprise value/tonne of \$72.4 for FY2009, which is at 27% discount to its replacement cost.
