The markets on 7 Feb: Sustain levels of 14450/4185.

LOOKING AHEAD: The market opened lower but sustained well above the level of 14450/4185, as a result of which the trend turned in the favor of the bulls.

Currently, the market is far away from its recent bottom of 14000/4050. This may invite a short-term correction if it fails to hold at higher levels on an intraday basis.

Also, Wednesday's gain was mainly due to a few index heavyweights like Bajaj Auto, ICICI Bank and Infosys. This may keep sentiments subdued and lackluster if other stocks fail to participate on Thursday.

A major support exists at 14400/4170 and a major resistance at 14700/4250. Buying is advisable on declines or when prices near recent bottom levels.
