## Market round up

Sensex rallied further posting new highs in the current week. Small correction was seen post Infosys results which disappointed the street. However other sectors continued to do well be it capital goods, infrastructure, cement, auto. Even some of the real estate plays did well. The star sector clearly was metals with steel sector particularly doing well. The interest in mid and small cap stocks continued and this segment of the market saw good activity. Sectors like cement, infrastructure, real estate and even pharma saw buying interest.

Infosys results were better than expectation but the downward revision of EPS guidance in rupee terms did not go down well with the market. As we said earlier, interestingly the mid cap software space remained reasonably firm. However the software sector's performance on the bourses may remain muted in the short term given the longer term concerns over the impact of exchange rate and the ability of companies to handle this change.

On the flows front, FIIs have been regular buyers in the cash market. On Friday, they were net buyers of Rs 1323 cr in cash market as per provisional data. DIIs meanwhile have been taking some profits and have been net sellers in most of the days.

#### Outlook for the week

Global markets continue to be strong. The overall interest in equity remains high. Flows into equity by FIIs have increased and all this augurs well for the domestic market. While the flows have brought momentum into the market, the broad market valuations are just about fair and in some sectors like media and capital goods, the valuations are quite rich too. Thus investors need to be more stock specific in their approach.





## **Corporate Round up**

**Oil and Natural Gas Corporation (ONGC)**, plans to add about 2,700 Mw of gas-based generation capacity, for both captive and commercial use, through three plants. This capacity will be larger than the 2,300 Mw capacity owned by Tata Power — the country's largest private power player.

The biggest of these plants will be a 1,000 Mw gas-based power plant at ONGC's special economic zone & will partly supply its petrochemical complex and its methane-propane extraction plant in the zone.

Another captive power plant at Mangalore will supply power to ONGC's upcoming petrochemical complex in the area.

The company is already implementing a 750 Mw gas-based power plant in Tripura with the state government, which is entirely for commercial use. The Tripura plant is expected to be ready in a year.

The exploration company is investing Rs 13,000 crore in setting up a petrochemical complex and a methane-propane extraction plant at Dahej. They are being jointly developed by ONGC and Gujarat Industrial Development Corporation.

**Reliance Communications** has awarded \$200 million (Rs 800 crore) network expansion contract to Chinese equipment vendor Huawei Technologies.

The new contract is for expansion of Reliance Communications' CDMA, GSM and next generation telecommunications networks in the country. At present, the Anil Ambani company is on a network expansion project to extend its services to over 20,000 towns and 600,000 villages.

Under the agreement, Huawei will supply and provide deployment services for CDMA and GSM base stations, and help in creating an Internet protocol next generation network infrastructure. Reliance Communications expects this to enhance its competitive advantage in attracting new subscribers.

**Tata Consultancy Services (TCS)** and CDMA applications provider Qualcomm have initiated discussions to jointly work on wireless communications technology and platforms. The companies would look at developing software that would improve wireless communication efficiencies and reduce the cost of mobile telephony operations.

The companies will mainly look at developing technologies that will help in improving wireless penetration by using lower amount of spectrum. The CDMA technology is hailed for its lower usage of spectrum, compared with the GSM, the other mobile technology used in the country.

#### Inflation rises again, Reaches 4.27%.

Inflation rose to 4.27 per cent for the present week ended as compared to 4.13 per cent in the previous week mainly due to increase in prices of food articles and some manufactured items. The wholesale price-based index stood at 5.21 percent in the corresponding week a year ago.

Rupee remained at Rs. 40.36 per dollar this week as against the previous week Rs. 40.48
