S&P Nifty (3818.30 points) (-166.95 pts)

Market players seemed least interested despite the positive measures taken to support the fragile economy. The Nifty crashed 138 points on the last trading day of the week. One has to admit the patience and perseverance shown by the Bears in the past 9 months. Every pullback met with fresh selling pressure dragging the Indices to new lows. Free fall in Metals continued with a whopping 11% cut. Reliance along with the IT, Realty and CGS sectors were battered down leading to a loss of another 4% in the benchmark Indices. Volumes were slightly lower than earlier week.

The Nifty breached the 3770 points support on last Tuesday but managed to close on the trendline in blue. A decisive breach of 3770 points may test 3724 and 3663 points. However failing to breach the earlier lows there is an outright possibility of a small pullback. Daily resistance line has shifted lower to 4068 points. A sustained move above 4110 points only may stall the downswing and to signal strength 4245 points must be decisively crossed.

From an immediate scenario, the Bears need to close below 3785 points for continuation of the downswing. Crucial support is at 3720-3744 points. Resistance is at 3920 points which if sustained can test 3995-4015 points. A close above it for a couple of sessions is required for a strong rally. Excess selling pressure is witnessed due to over reaction. Coming days are going to be an acid test for the Bulls. They need to shrug off the past and stand out together to arrest the downfall otherwise the Bear party is on.
