Derivatives Summary

- Nifty (October) future premium has increased from 20.35 points to 23.25 points and around 10.66 lakh shares were added in open interest.
- Total open interest in the market was Rs60,022 crore and Rs1,719 crore were reduced in open interest.
- Nifty call option added 45.05 lakh shares in open interest, whereas put option shed 7.51 lakh shares in open interest.
- Tata Communications (15%), Chambal Fertilisers and Chemicals (11%), Crompton Greaves (10%), Indiabulls Real Estate (10%), and Tata Power (9%) were the top open interest gainers in the market.
- Skumars (-39%), HOEC (-17%), NIIT Technologies (-12%) and Voltas (-8%) were the top open interest losers in the market.

Market View

The market opened on a dismal note, around 130 points lower, on account of uncertainty in the global markets. Aggressive selling pressure along with very high volatility was witnessed all through the day. Nifty finally ended almost 6% down at 3,602. Volumes in Nifty futures were significantly higher than the average trading volumes. Around 10.66 lakh shares were added in open interest with an increase in the cost of carry indicating long accumulation. On the option front, implied volatility has increased significantly by around 500-600 basis points across all strike prices, which indicate that volatility will remain very high.
