Derivatives Summary

- The premium in the Nifty (April) futures increased to 7.2 points from 0.75 point and the futures shed around 64 lakh shares in the open interest while the Nifty (May) futures added 62 lakh shares in the open interest.
- The Nifty 50 stocks shed 35.40 lakh shares in the open interest.
- The total open interest in the market is Rs63,172 crore and there was an addition of around Rs1,220 crore in the open interest during the day.
- SCI (42%), Chambal Fertilisers (26%), Alok Textile (20%), Patni (19%), Kotak Bank (17%) and IFCI (16%) were the top open interest gainers in the market.
- Indian Bank (-36%), GDL (-15%) and Sesa Goa (-14%) were the top open interest losers in the market.
- Divis Lab (107%), Arvind Mill (101%) and IFCI (101%) are close to their market wide position limits.

Market View

The market opened on a weak note and remained in negative territory for the first half of the trading session. The Nifty bounced back smartly and entered positive territory on short covering and fresh buying and finally settled at 4167 with gains of more than half a percent. The volumes in the Nifty futures declined a bit but were higher then the average volumes on account of roll-over and the futures shed around 73,000 shares in the open interest. On the options front, the implied volatility of the calls decreased whereas the implied volatility of the puts increased indicating we might have a volatile session tomorrow. The market is likely to open on a flat note and will take a cue from the world markets. The movement in the Nifty is likely to be random in the second half of the session on account of the April month expiry tomorrow. The key support level for the Nifty is 4100 and there will be resistance around 4200.
