### **Corporate Snippets**

- Against the backdrop of eight successful product launches in 2006-07, Hero Honda has registered a 11.2% increase in sales as against the previous fiscal year. –BS
- Bajaj Auto saw a robust motorcycle growth at 24% in FY07, on the back of strong pull for its lead brand Bajaj Pulsar. The motorcycle market share for the company improved from 30.8% in FY06 to 33.5% in FY07. –BS
- The petroleum ministry has cleared a Rs 18,000 crore investment plan of GAIL India. This will fund five new pipelines and increase the capacity of three existing lines. –BS
- Amtek Auto has inked a 50:50 Joint venture deal with VCST Industrial Products byba of Belgium to set up a state-of-the-art manufacturing facility for powertrain components in India. –BS
- Bank of Baroda will tie-up with UK-based insurance company Legal & General to undertake life insurance business in India.ET
- GAIL (India) Ltd will infuse Rs 500 crore in the cash-starved Ratnagiri Gas and Power Pvt Ltd, the owner of the Dabhol project, provided the state-run gas utility is given the adjacent LNG terminal. –ET
- Reliance Industries Ltd, plans to build two gas pipelines in southern India that could help the energy explorer supply gas from its deep-sea fields to retail consumers. –ET
- Ballarpur Industries Ltd plans to raise uncoated paper prices by 600-750 rupees a tonne from April 1. –ET
- Patel Engineering has bagged a Rs 806 crore in joint venture with Gammon Ltd for a hydroelectric project from Satluj Jal Vidyut Nigam Ltd. –ET

#### Macro Economic & Geo-Political News

- The Reserve Bank of India has hiked the repo rate by 25 bps to 7.75% with immediate effect. The apex bank has also hiked the CRR for banks by 50 bps to 6.5% in two phases. In the first phase, the CRR will be hiked to 6.25% from April 14 and to 6.5% from April 28. –BS
- For the third week in a row, inflation remained unchanged at a high 6.46% for the seven days till March 17, putting further pressure on interest rates ahead of RBI's monetary policy next month. –BS
- India's external debt increased 6.2 billion dollar to 142.7 billion dollar at the end of December 2006, according to finance ministry data. –ET

(Rs 91, FY08E - P/E 4x, BUY, Target Price Rs 150, Earlier recommended at Rs 68)

PIL has come a long way to capture the booming Indian IT sector, with a modest beginning as a System Integrator to a provider of varied range of services and offering.

PIL has chalked out a well-defined path for growth, which comprises of both the organic and inorganic initiatives to garner the incremental IT spending in both the domestic and global market, and PIL's recent acquisitions of LGI is synergetic to leverage the latter's global presence and derisk the geographical risk.

#### Paradyne Infotech acquires LGI Inc:

Paradyne Infotech has recently acquired LGI Inc. (Links Group International Inc.) based in Virginia, US. The acquisition is all cash deals, with a cash consideration of \$ 4.75 mn. Paradyne Infotech signed the purchase agreement to acquire 100% stake in LGI, through its US subsidiary Dyne Techservices. The deal was finance through the both the debt and internal accruals, with debt comprises of major part to the tune of around \$4.15 mn.

#### **Synergies:**

- Around 90% of the PIL's revenues are generated from India, and rest is coming from the US region, with these acquisitions, PIL will able to derisk its geographical risk to a certain extent.
- LGI has got a better cliental profile and relationships, with robust IT spending capability. PIL with its offshore delivery model would leverage these relationships to garner incremental spending from LGI's clients.
- LGI's with a gross margin of close to 20% and net margin of around 16%, is way higher than PIL's net margin of around 10-11%, going forward with strong ramp up in the LGI's accounts and incremental contribution to the total revenue, can improve the consolidated net margins substantially in the coming years.

#### **Business Outlook and Valuation: Attractive Valuation**

Going forward, we expect robust business tractions will continue for Paradyne, and with increasing acceptability of its product and services in the domestic IT industry and successful integration of LGI would provide further fillip to the growth prospects for the coming years.

We have revised our estimates for FY08, on the back of PIL's recent acquisitions of LGI. We expect Paradyne to grow at a CAGR growth of 62% and 85% in revenue and net profits over FY06-08E, to Rs 2266 mn with net profits estimated at 250 mn respectively by FY08E.

Currently, PIL is trading at 4x FY08E, we maintains BUY on the stock with a price target of Rs 150, at our target price the stock will be valued at 6.5x for FY08E.
