Markets slipped in the opening following the mixed global cues but soon bounced back into the green zone . Metal, Oil & Gas, Consumer Durables and Power stocks witnessed some buying interest while FMCG, Realty and Capital Goods stocks remained under pressure in the early trade. Eventually as trade proceeded towards the mid morning session volatility took the grip of the market. The market breadth indicating the overall health was in favour of the advances. All throughout this session the indices kept on hovering above the unchanged mark. At noon markets started to oscillate between the positive and negative terrain. Revival in monsoon situation and a survey indicating an improvement in business confidence of India Inc proved to be a catalyst that drove the markets up while choppy trade in Asian stocks hampered investor sentiments. In the early afternoon session choppiness was witnessed across the bourses as the European markets extended weak signals to domestic indices. In the last session fresh round of buying interest again took the indices back into the green terrain. Ultimately markets made a flat close. The overall volume of the market was moderate. Among the Nifty stocks HINDALCO, RELIANCE, PNB, CAIRN soared high while BPCL, DLF, BHARTIARTL, JINDALSTEL lagged behind.

Global News

Australian consumer sentiment rise 5.2%

An index of consumer sentiment in Australia advanced 5.2% in September from a month earlier to its highest level since July 2007. The index rose 34.4% over the last four months.

Australian retail sales down

Australian retail sales unexpectedly down in July as retail sales dropped 1 percent from June. The number of loans granted to build or buy houses and apartments fell 2 percent.

German industrial output down in July

Germany's industrial production slipped 0.9% in July from the previous month. The data was much worse than analysts expected as market participants expected a hike of about 1.6%. Output rose by a revised 0.8% in June from May.

HCL net profit up 4.08%

Net profit of HCL Infosystems rose 4.08% to Rs 68.37 crore in the quarter ended June 2009 as against Rs 65.69 crore during the quarter ended June 2008. Sales rose 0.57% to Rs 3099.57 crore in the quarter ended June 2009 as against Rs 3081.90 crore during the quarter ended June 2008.

For the full year, net profit declined 14.54% to Rs 260.44 crore in the year ended June 2009 as against Rs 304.75 crore during the year ended June 2008. Sales rose 0.02% to Rs 12210.73 crore in the year ended June 2009 as against Rs 12208.77 crore during the previous year ended June 2008.

- Markets opened on a weak note following the mixed global cues. But * immediately managed to rebound back into the green zone. NSE Nifty held above the 4800 mark in the early trade. The broader market indices traded marginally higher in the opening trade. Metal, Oil & Gas, Consumer Durables and Power stocks witnessed some buying interest while FMCG, Realty and Capital Goods stocks remained under pressure. After a subdued opening, the key benchmark indices traded above the unchanged mark in the mid morning session. Volatility took the grip of the market as the trade proceeded. After a shaky start, markets traded amidst volatility, swinging between positive and negative terrain at noon. Revival in monsoon situation and a survey indicating an improvement in business confidence of India Inc proved to be a catalyst that drove the markets up while choppy trade in Asian stocks hampered investor sentiments. From the early afternoon session onwards buying interest returned back again. Ultimately the markets chose to consolidate above the unchanged mark. Among the sectors Oil&Gas, Banks, Pharma fronted the rally while Realty, Telecom, Consumer Goods stocks lagged behind.
- BSE Midcap Index ended lower 2.96 points or 0.05% to 5939.81 while Smallcap Index closed higher 4.43 points or 0.06% at 7183.38.
- NSE Nifty touched an intra-day high of 4825.05 and low of 4783.50 while BSE Sensex touched an intra-day high of 16215.74 and low of 16044.77
- Finally Nifty ended higher by 9.00 points at 4814.25 and Sensex closed higher by 59.88 points at 16183.55
- HINDALCO, RELIANCE, PNB, CAIRN & HDFC were the major gainers where as BPCL, DLF, BHARTIARTL, JINDALSTEL & HEROHONDA were the major losers among the Nifty stocks.
- Nifty may find support at around 4780 and resistance at around 4855.
